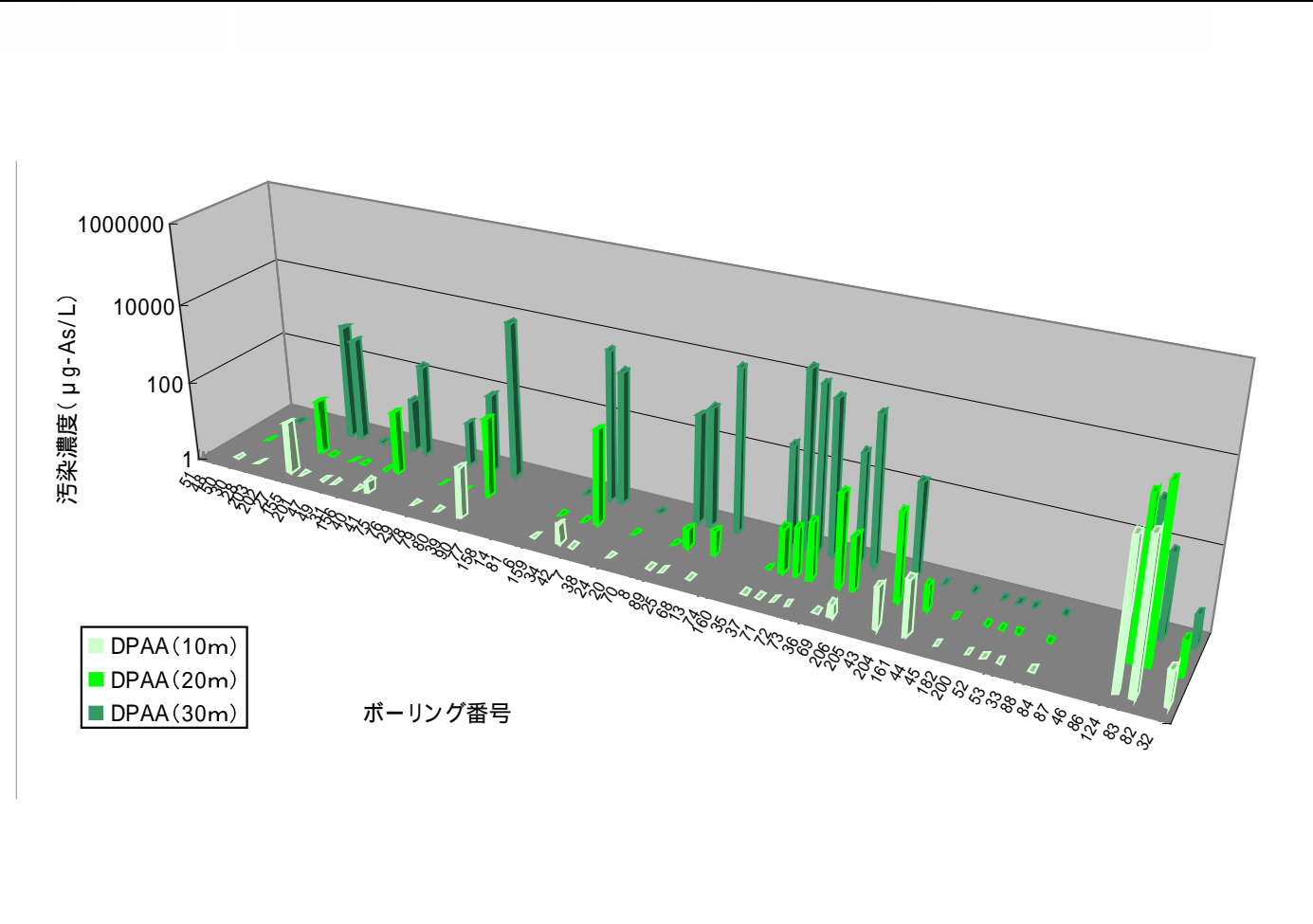
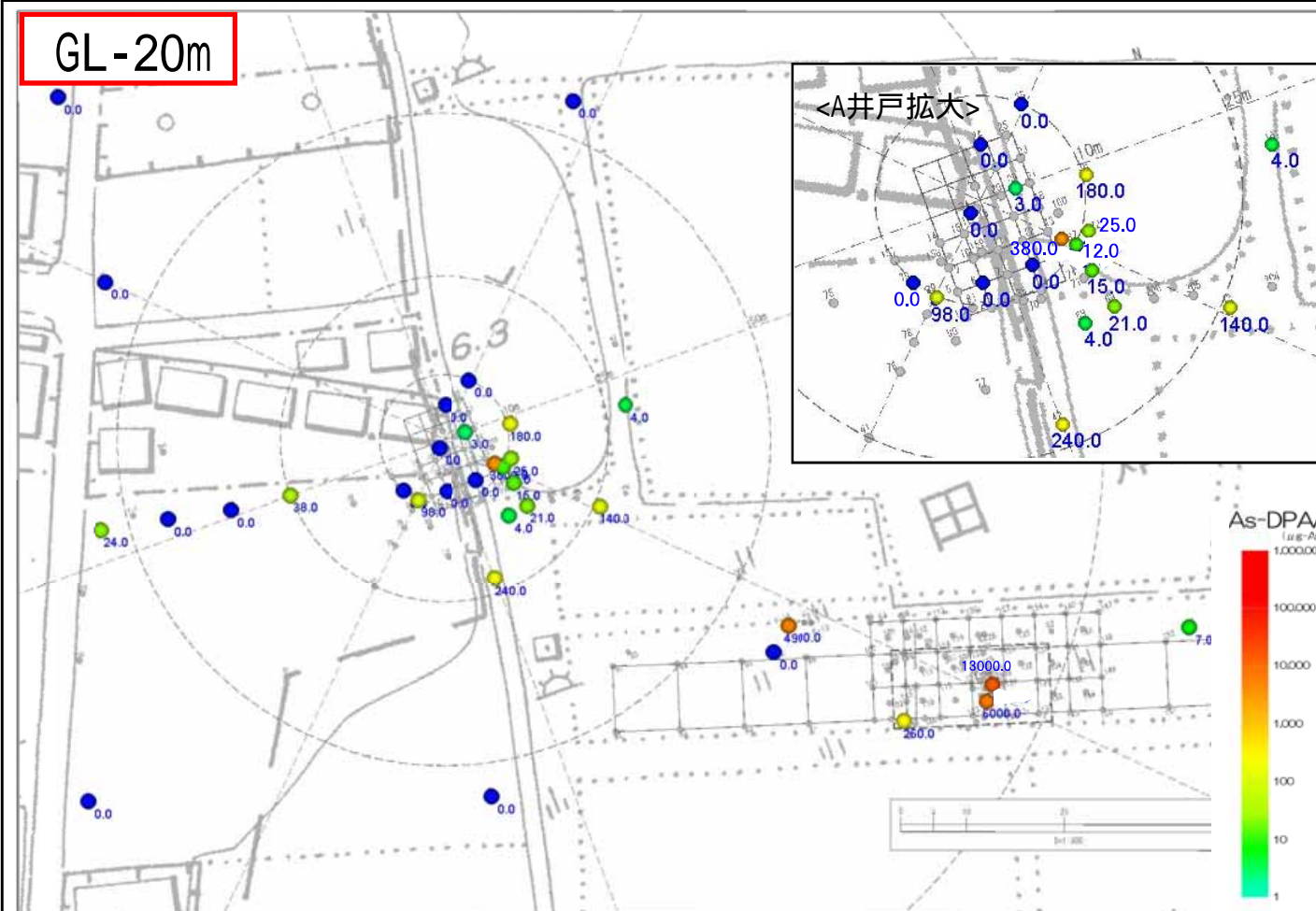
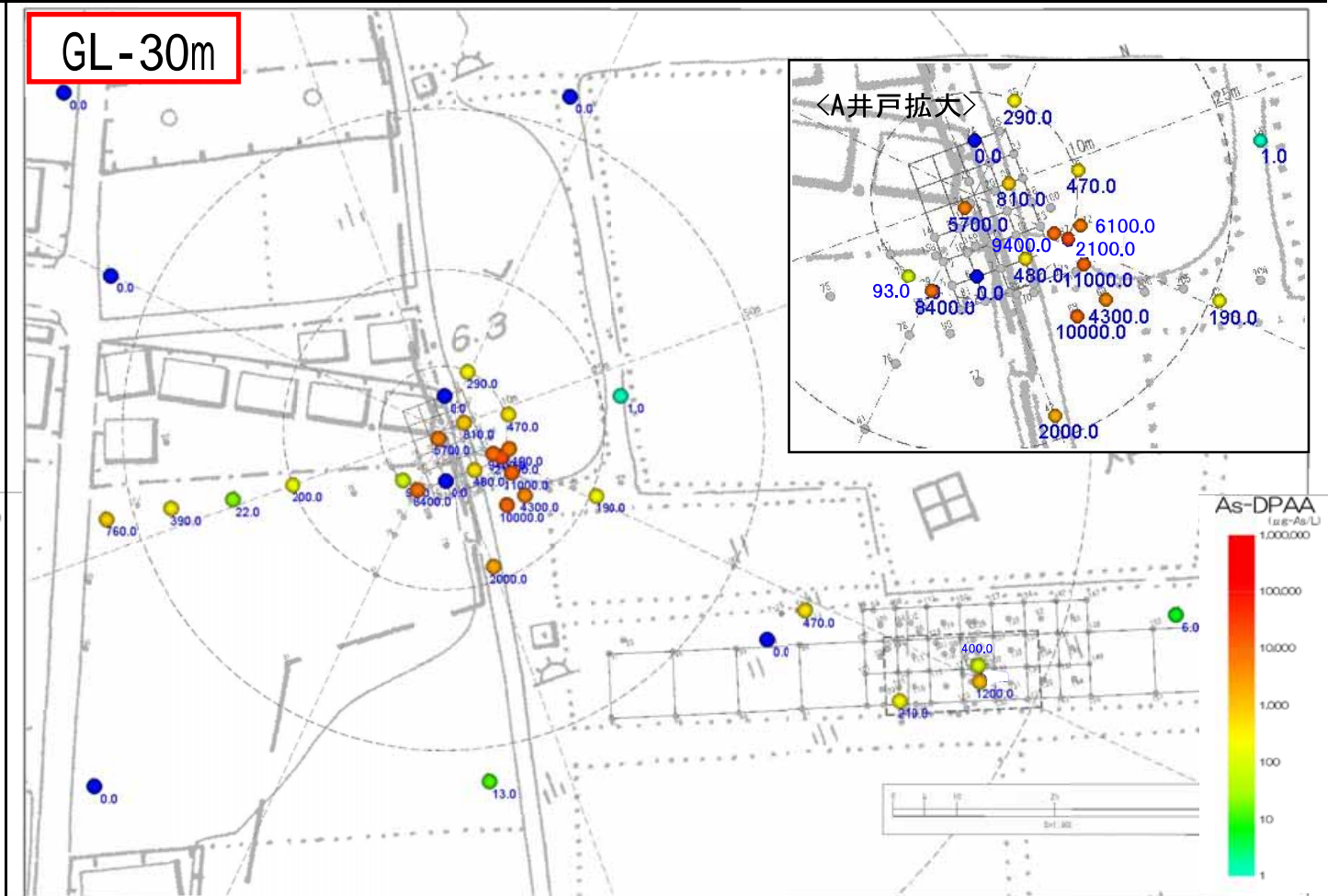
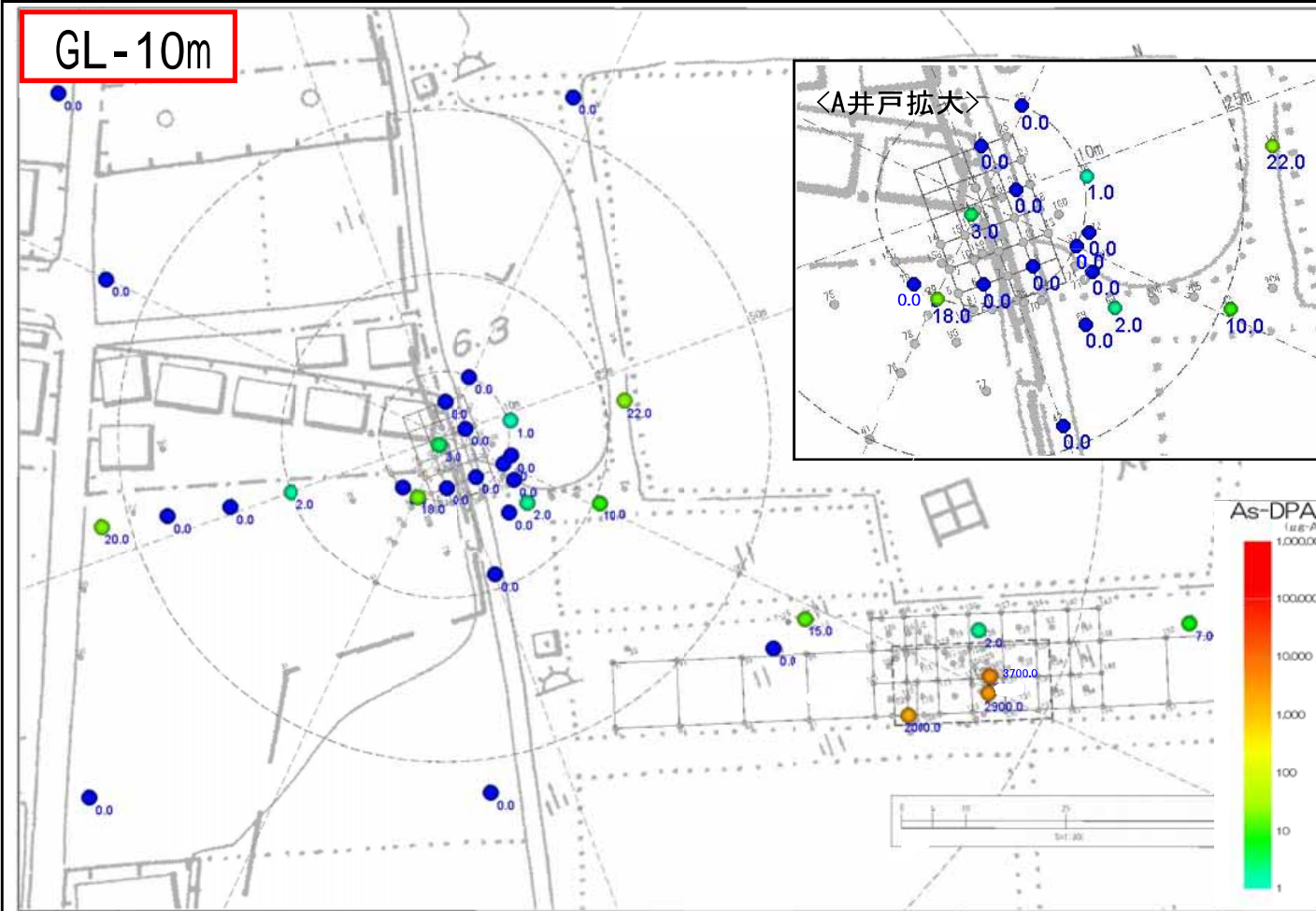


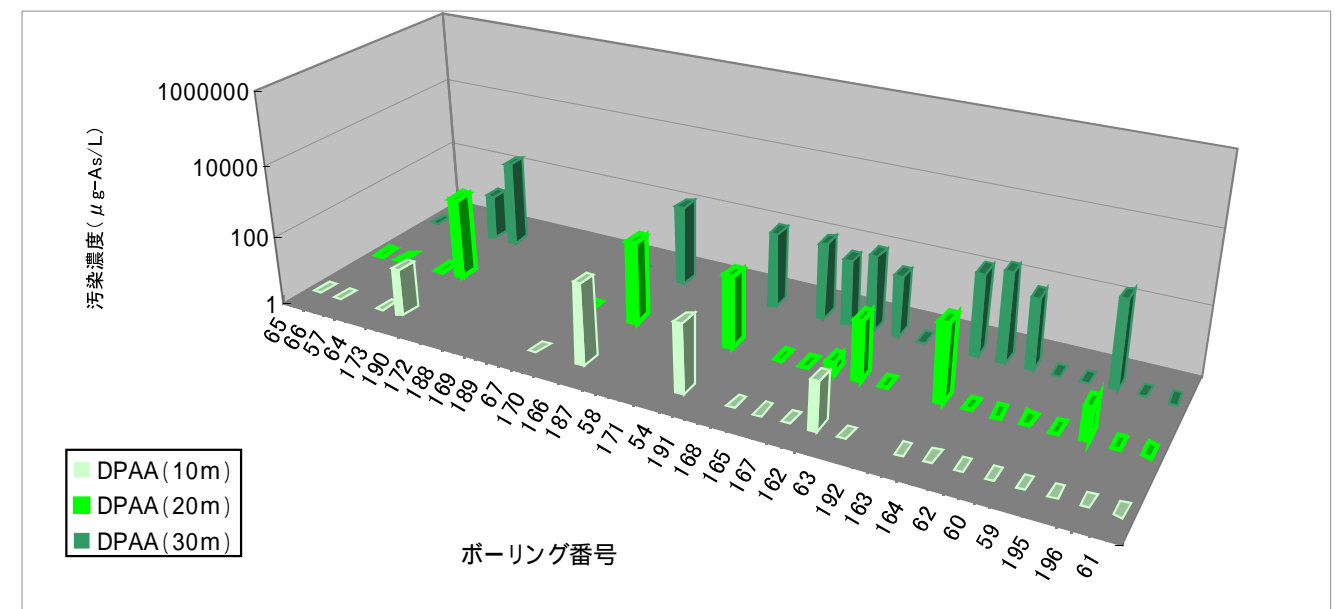
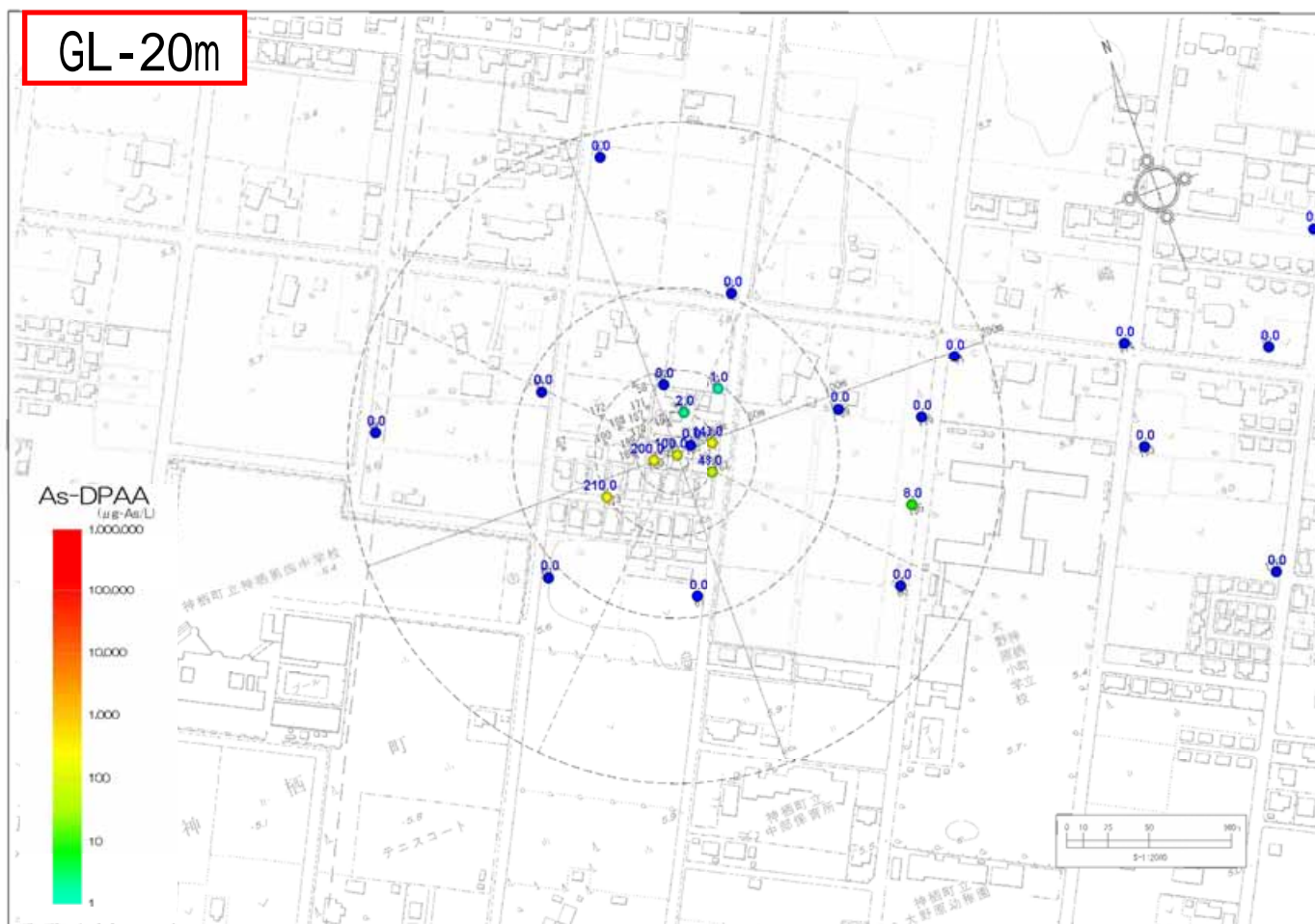
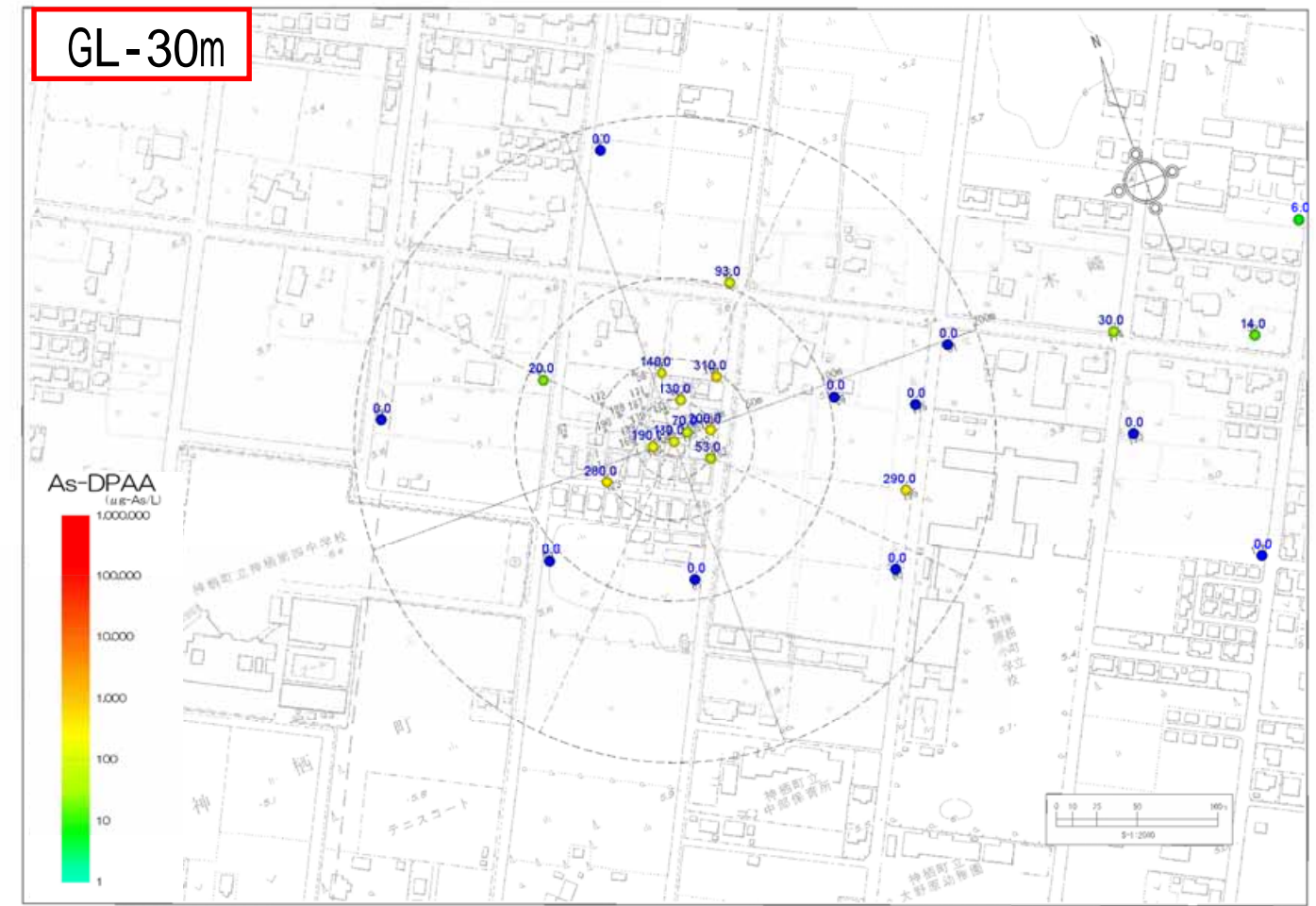
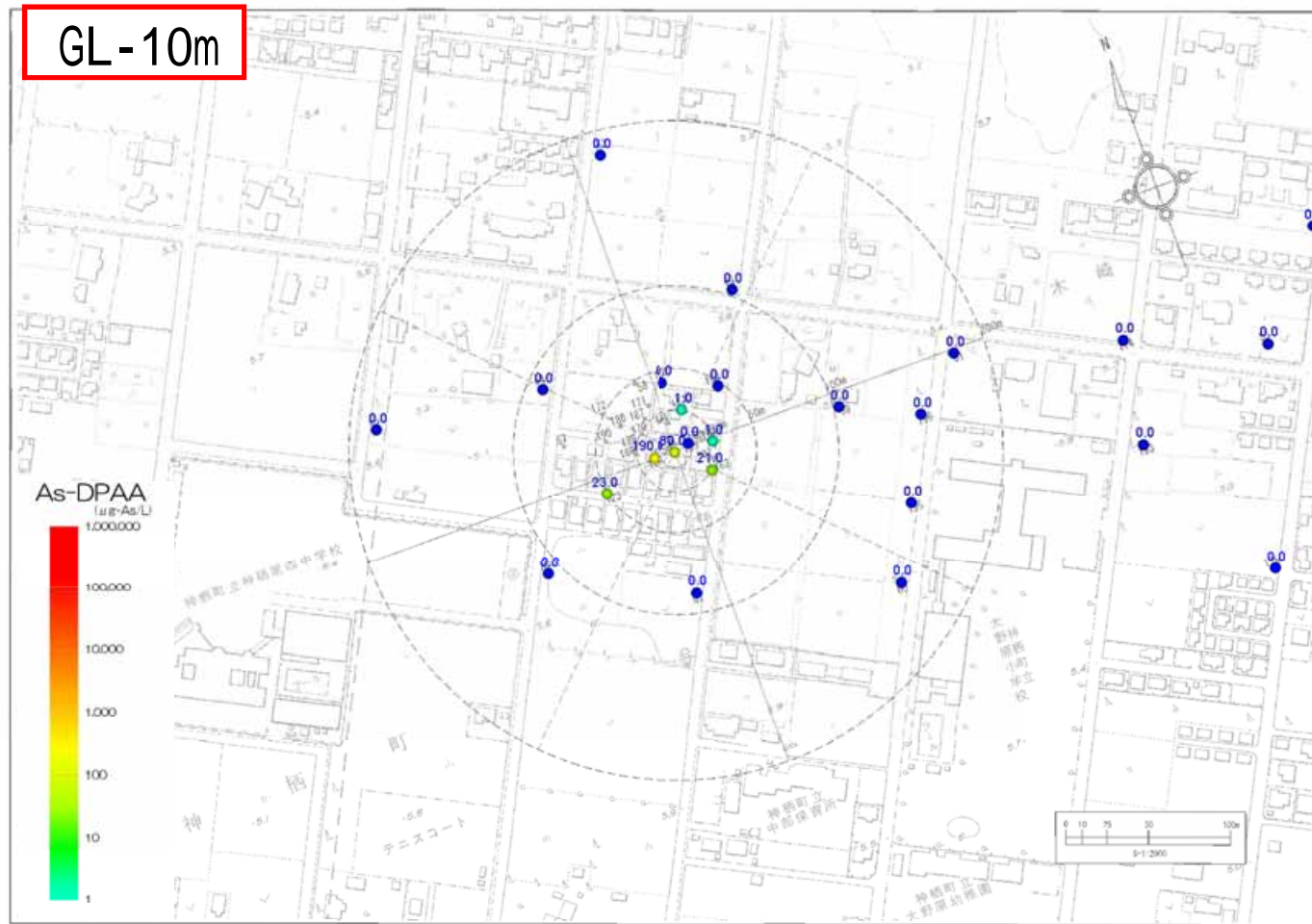
参考図2.4.46 2008年春季(4月)A井戸周辺地下水DPAA汚染状況図

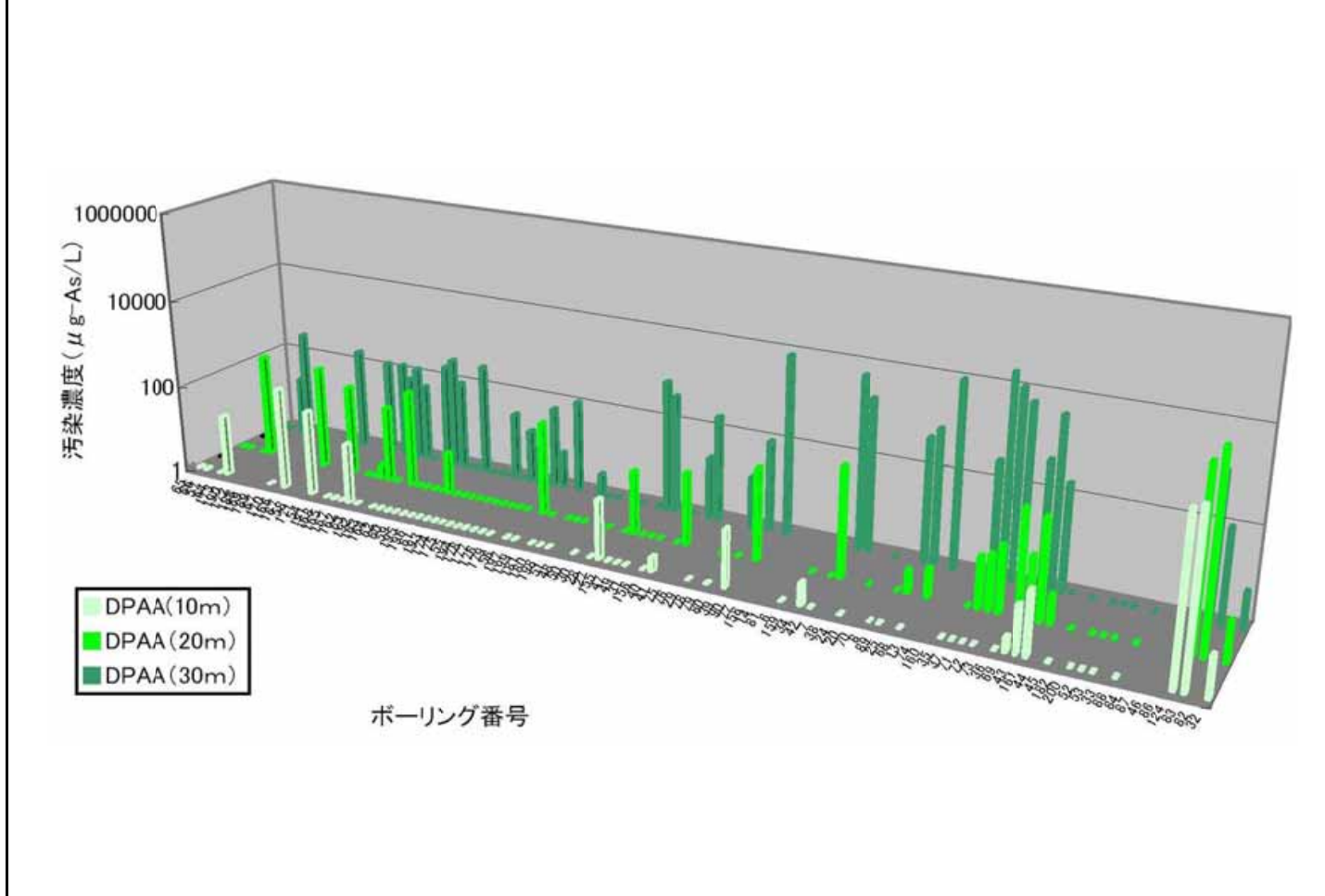
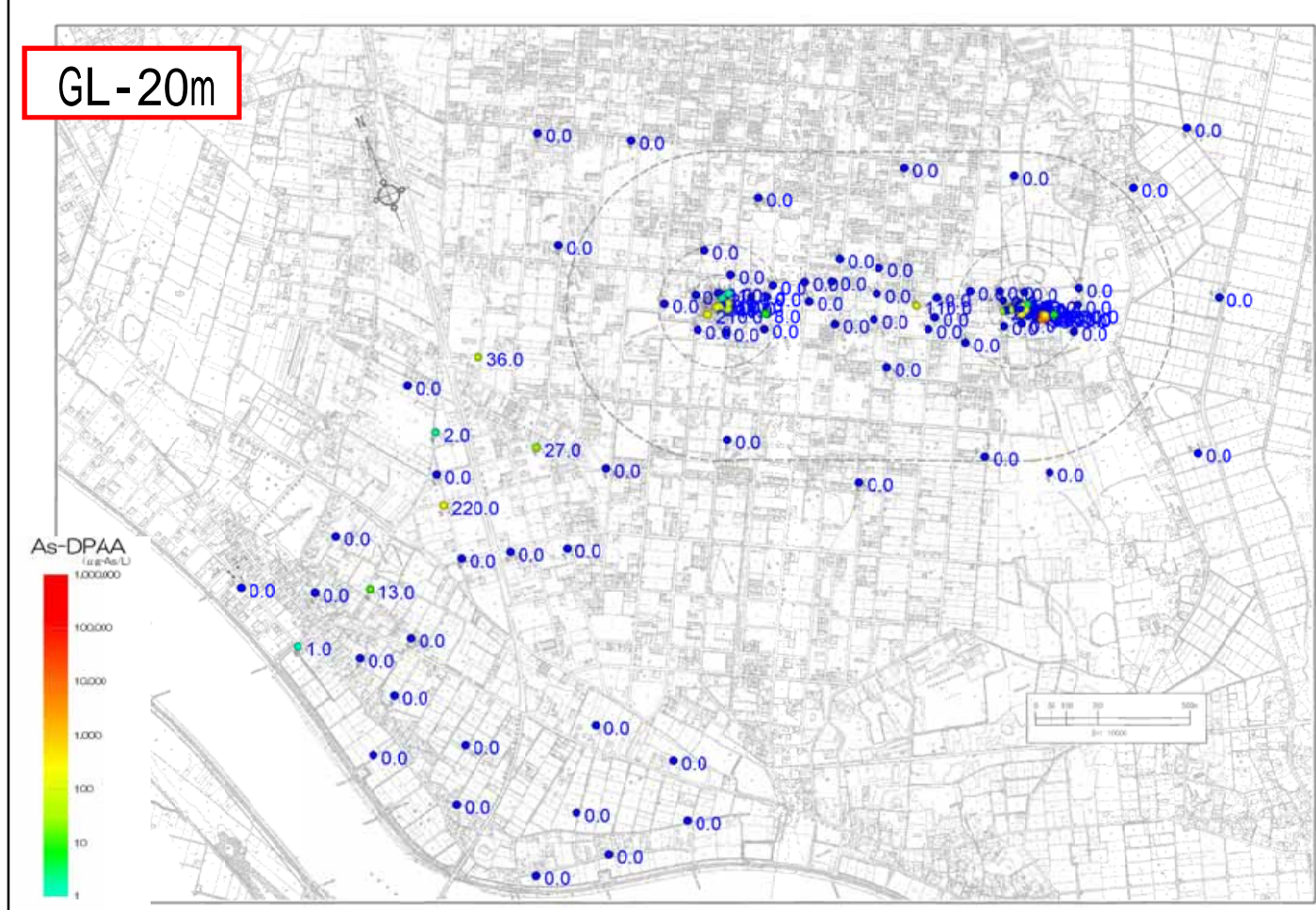
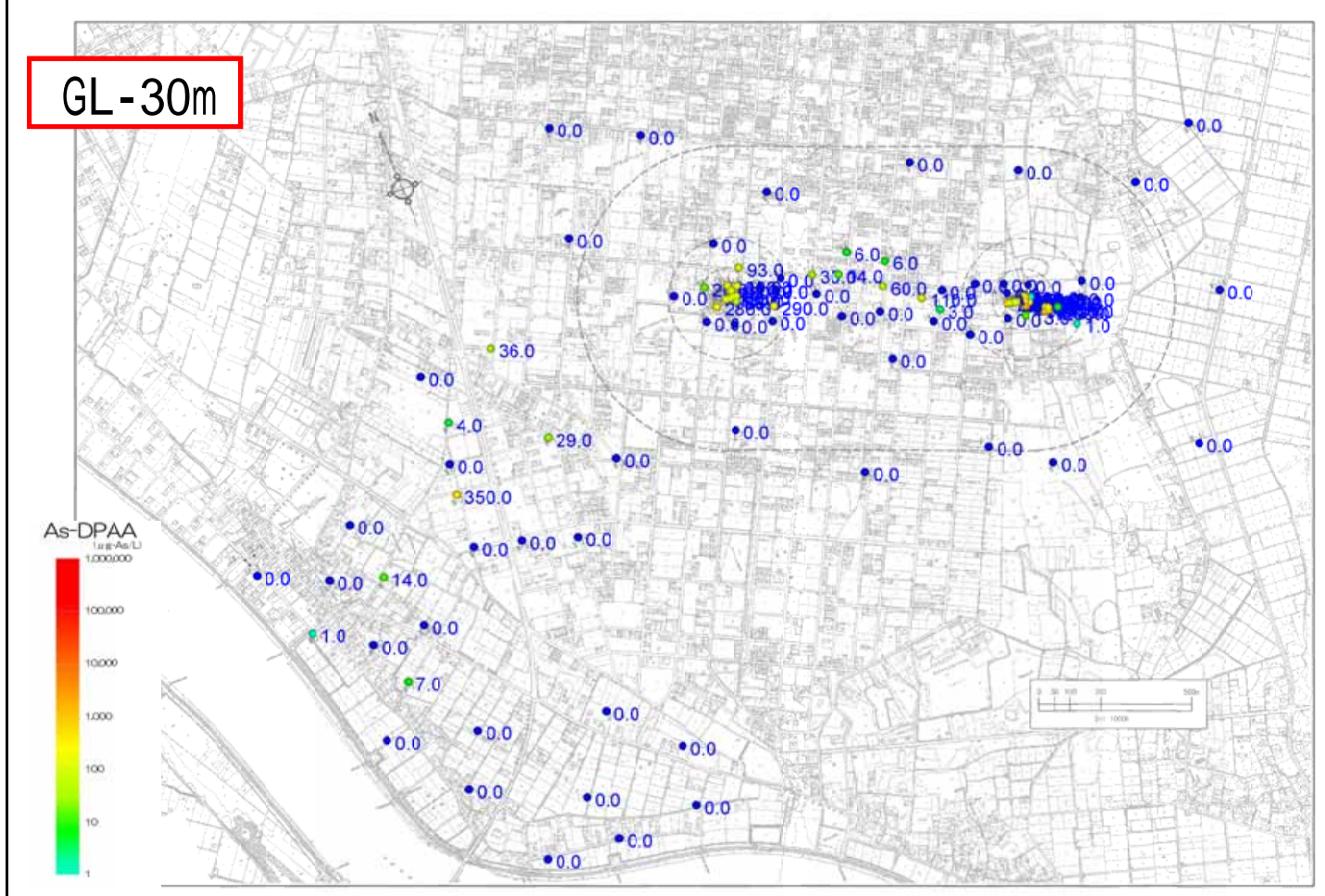
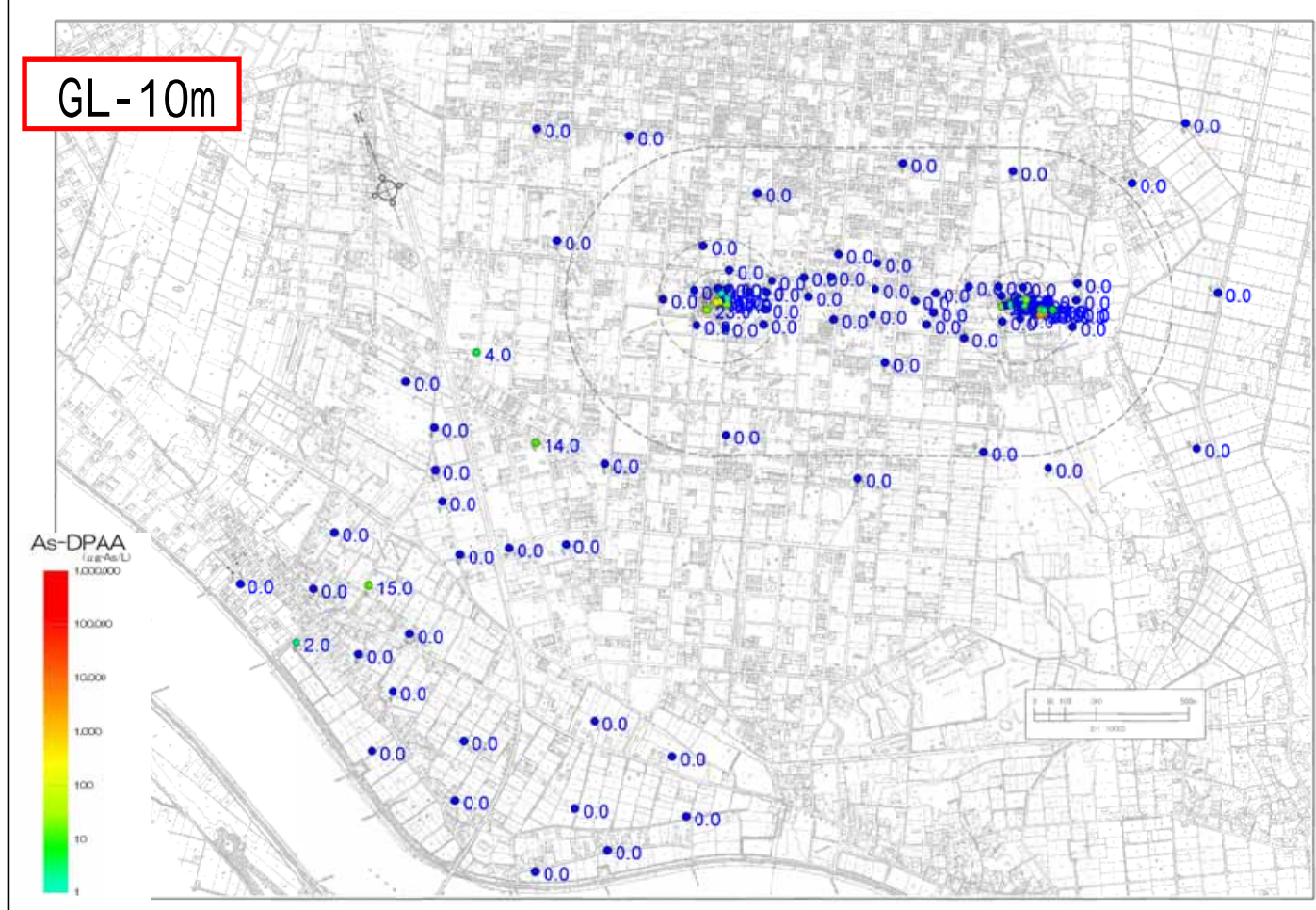
参考図2.4.47 2008年春季(4月)B地区地下水DPAA汚染状況図

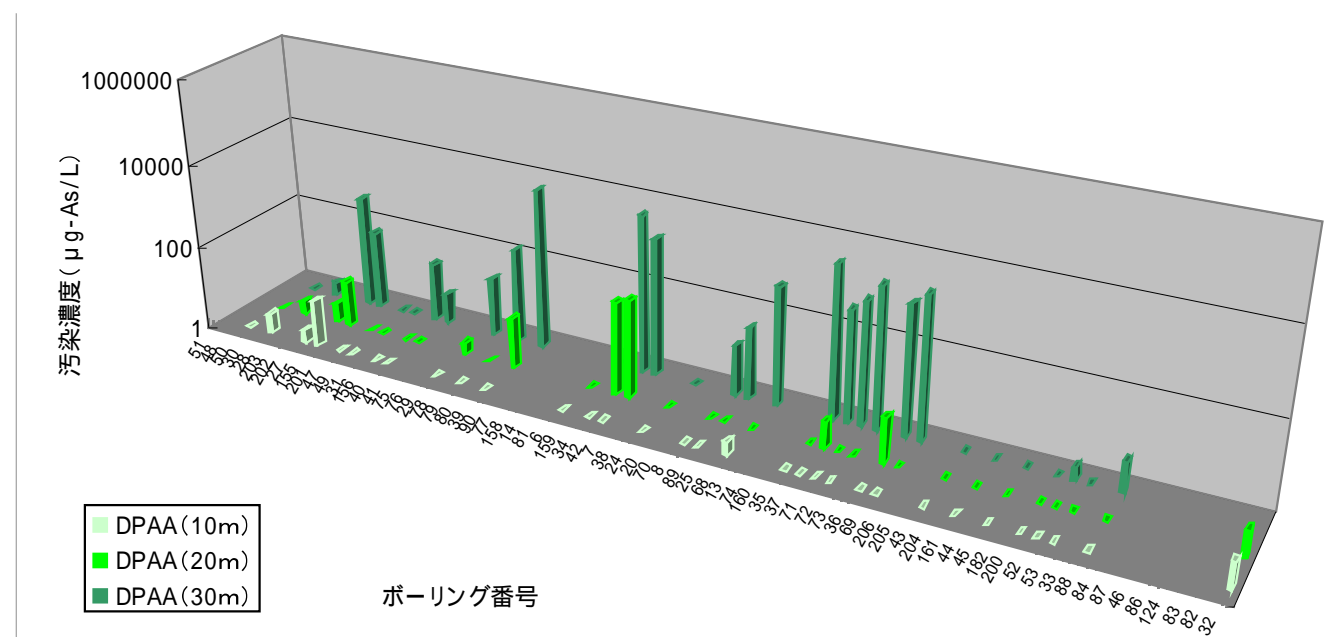
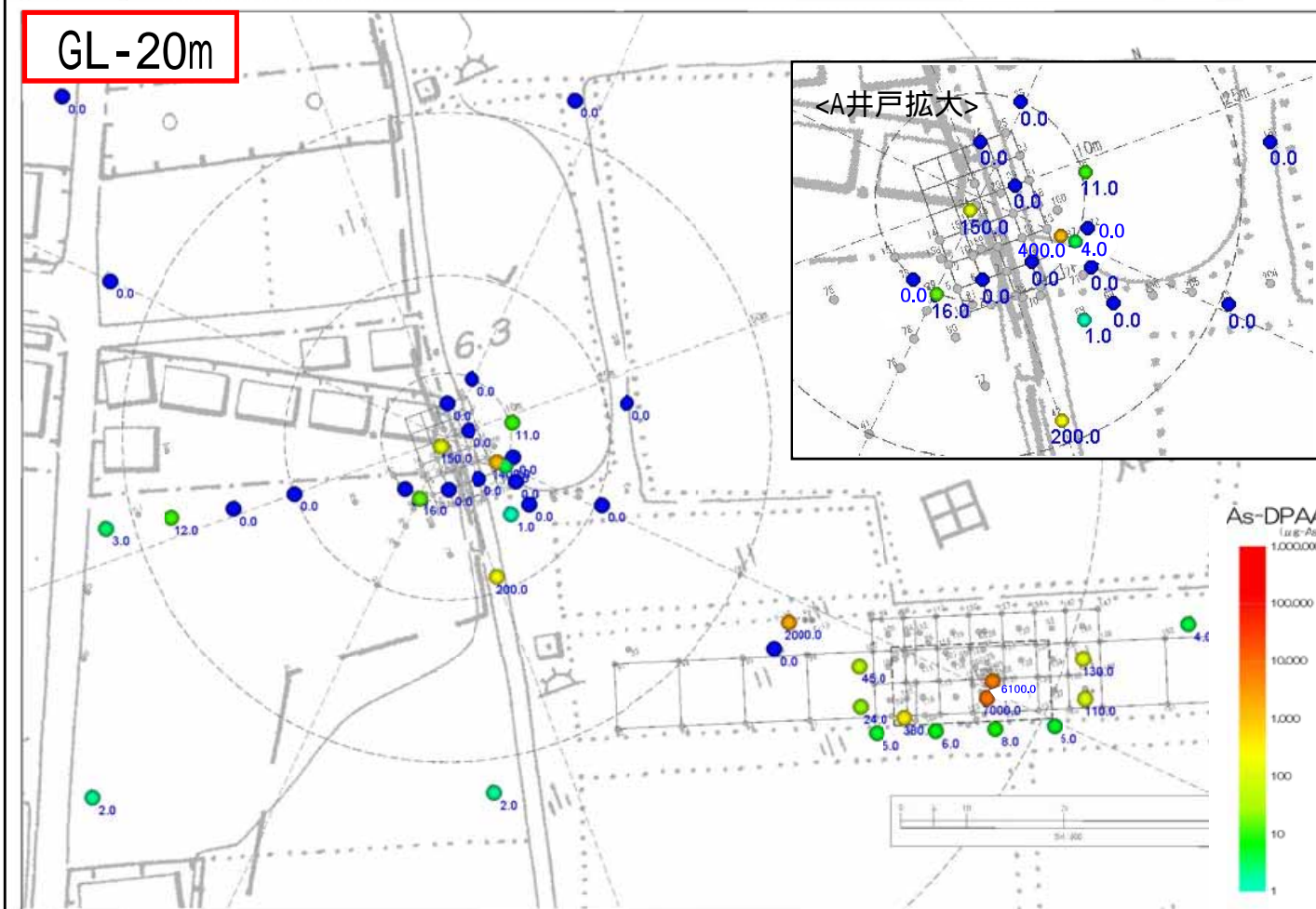
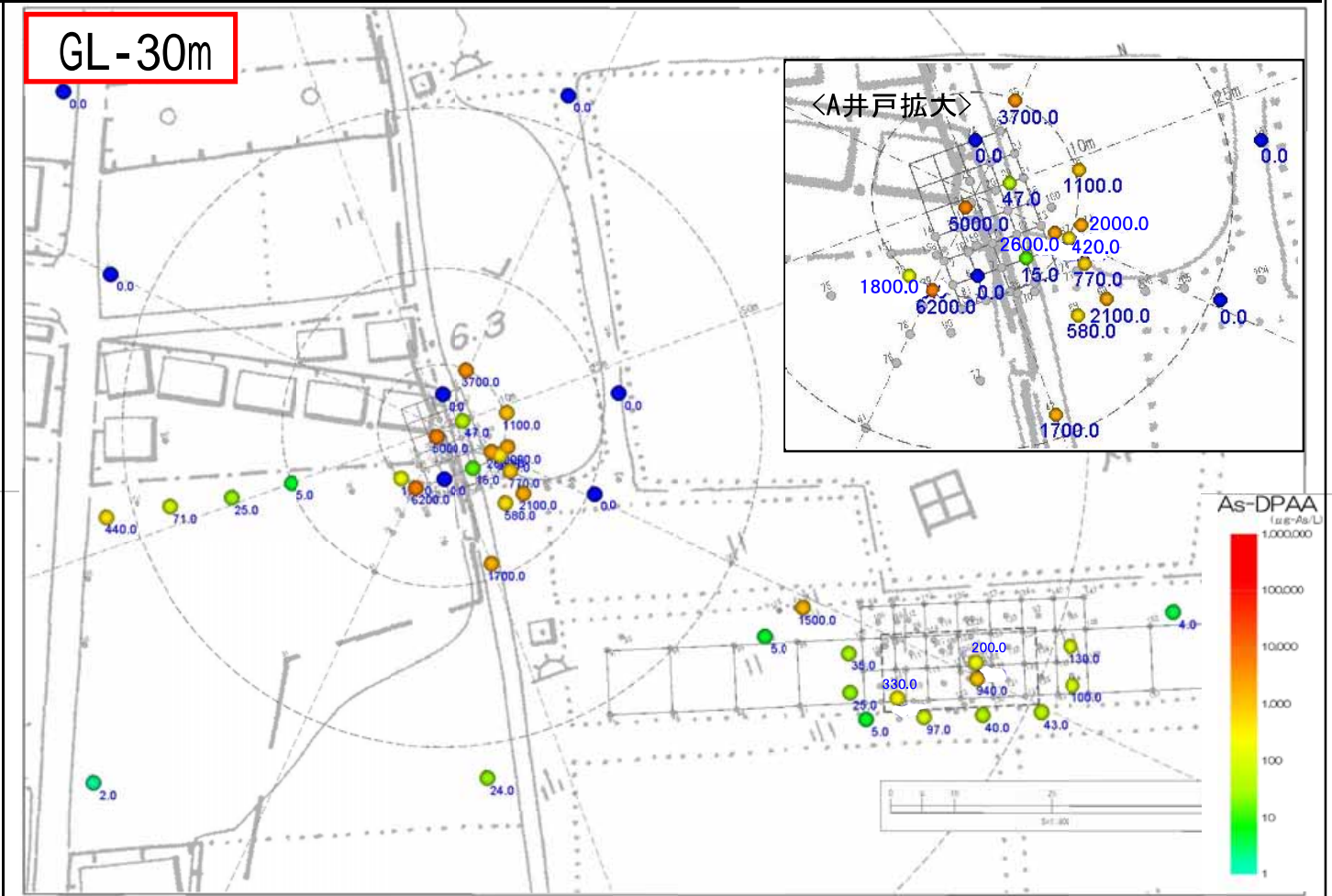
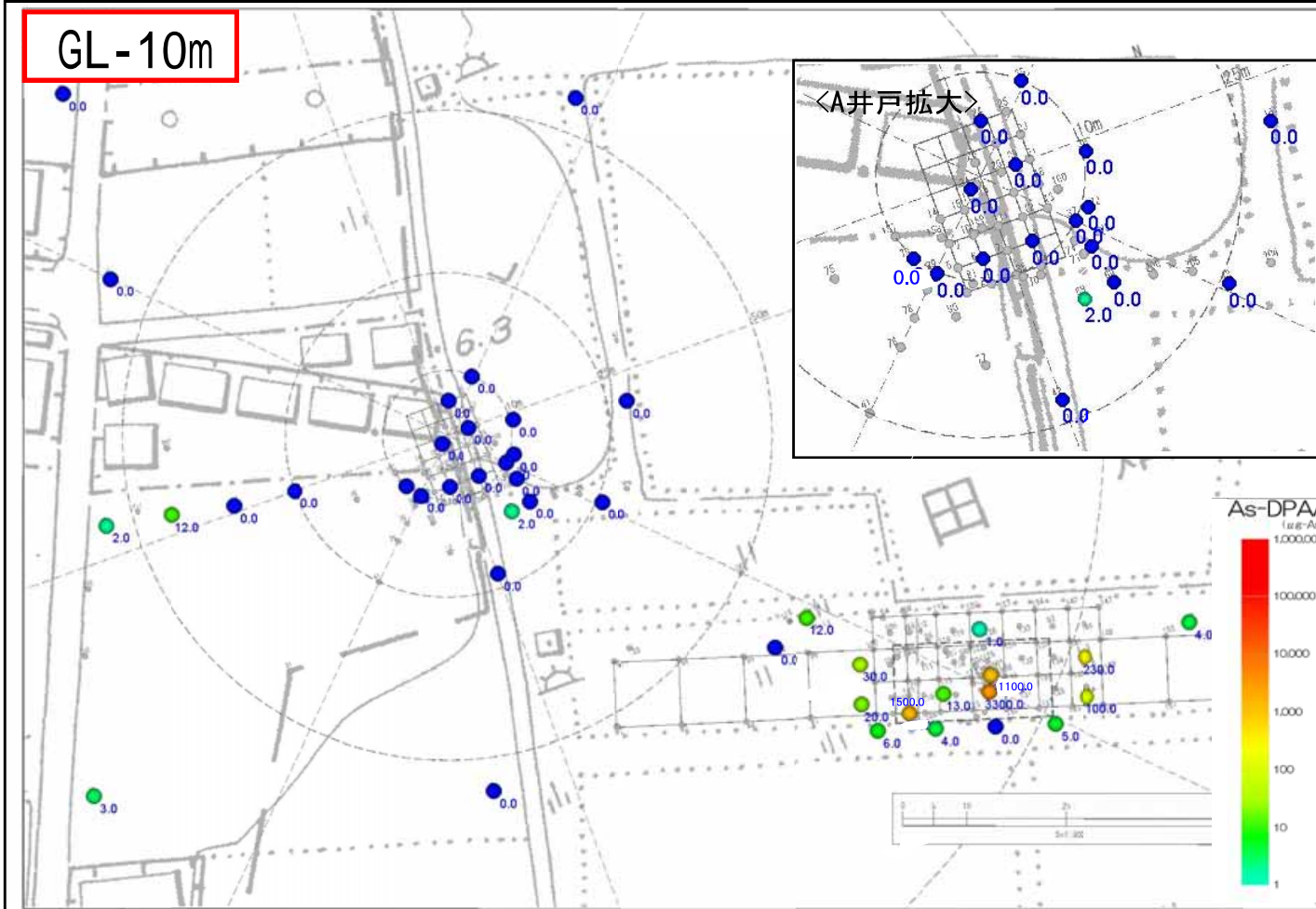
参考図2.4.51 2008年夏季(7月)ABトラック地下水DPAA汚染状況図

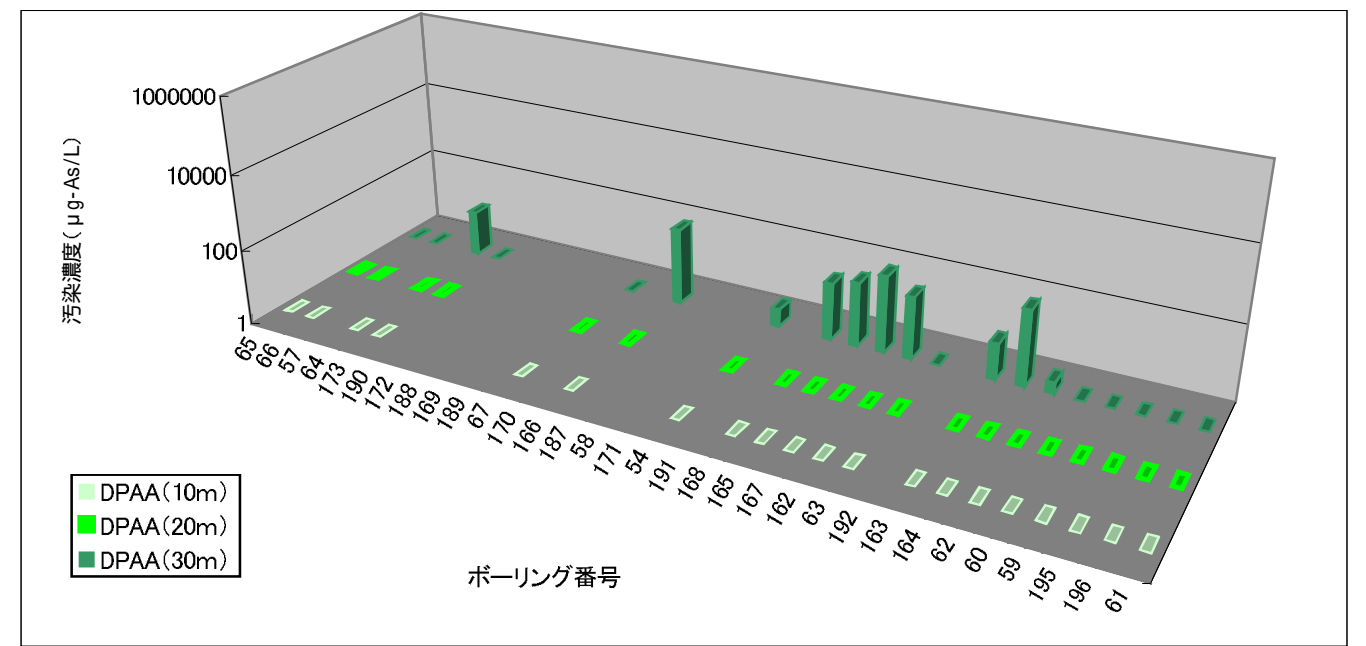
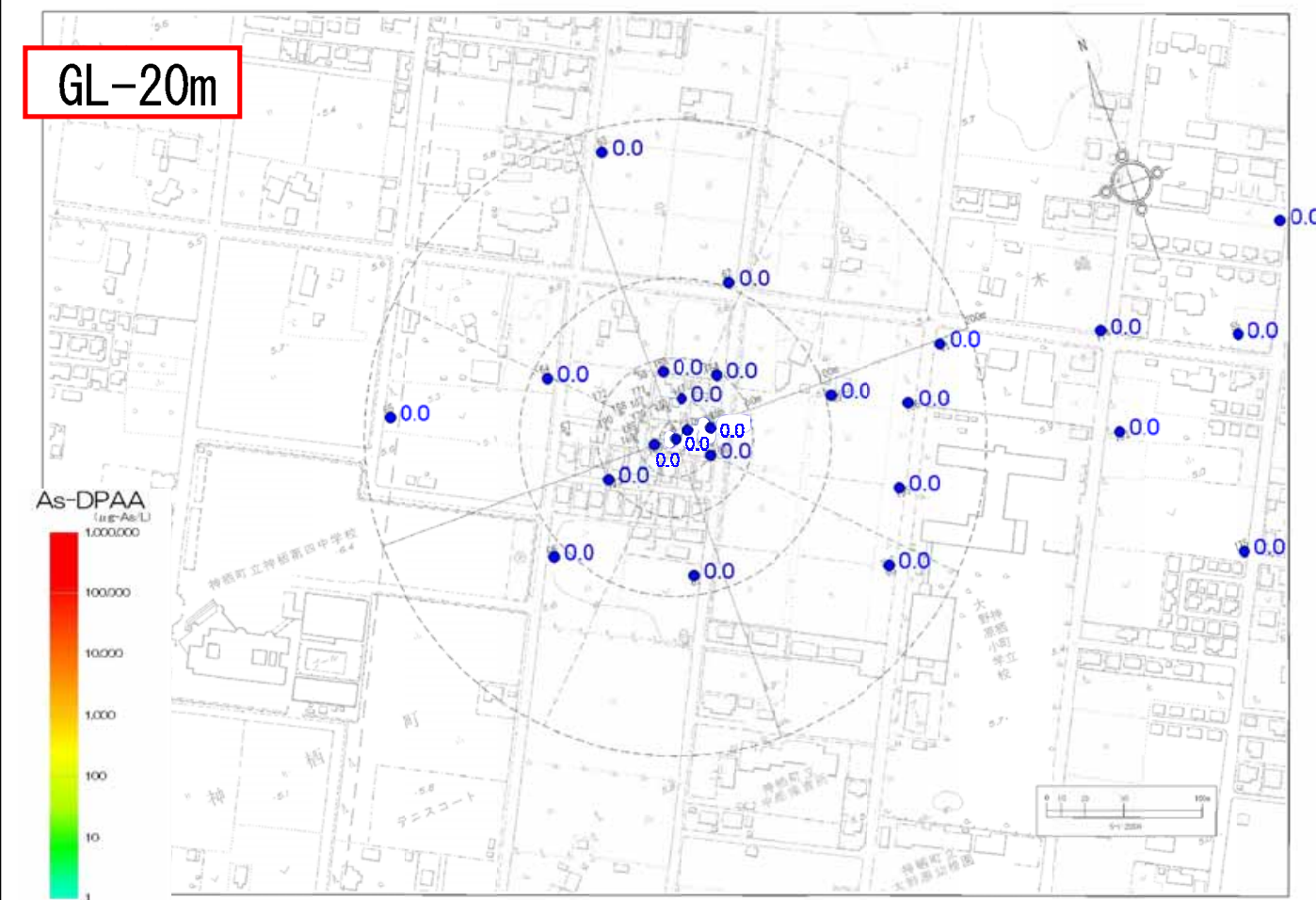
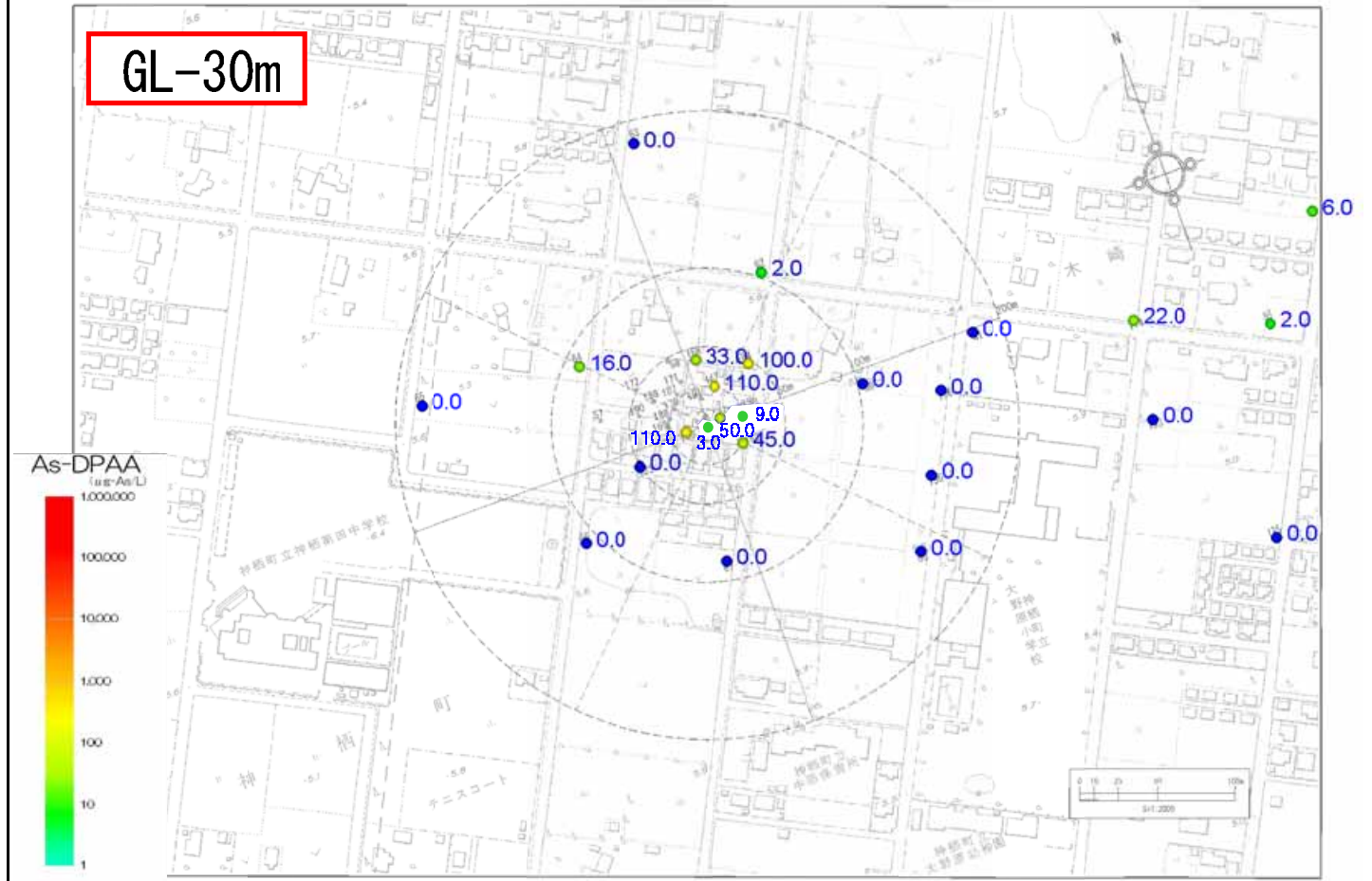
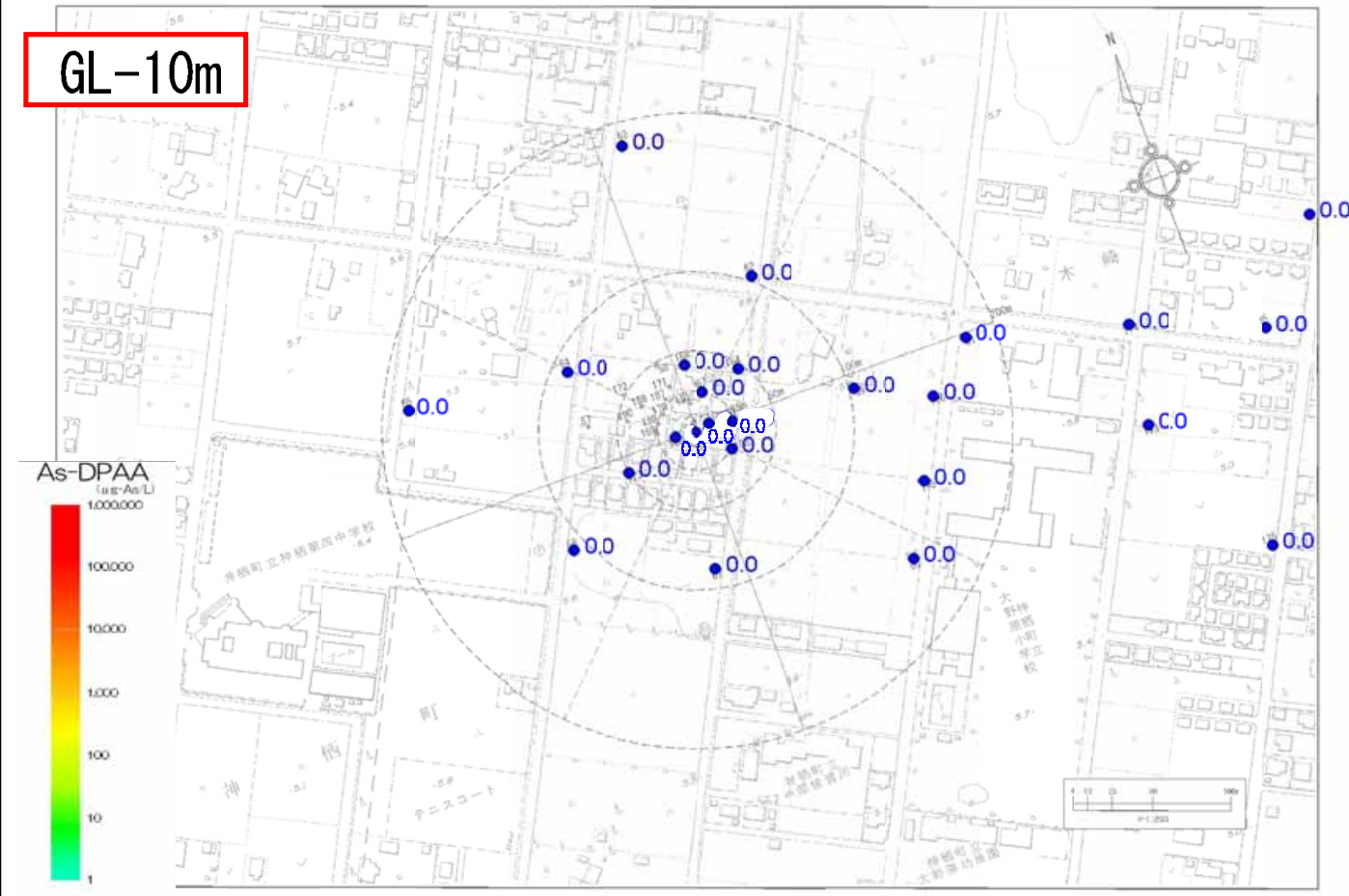
参考図2.4.52 2008年秋季(10月)A井戸周辺地下水DPAA汚染状況図

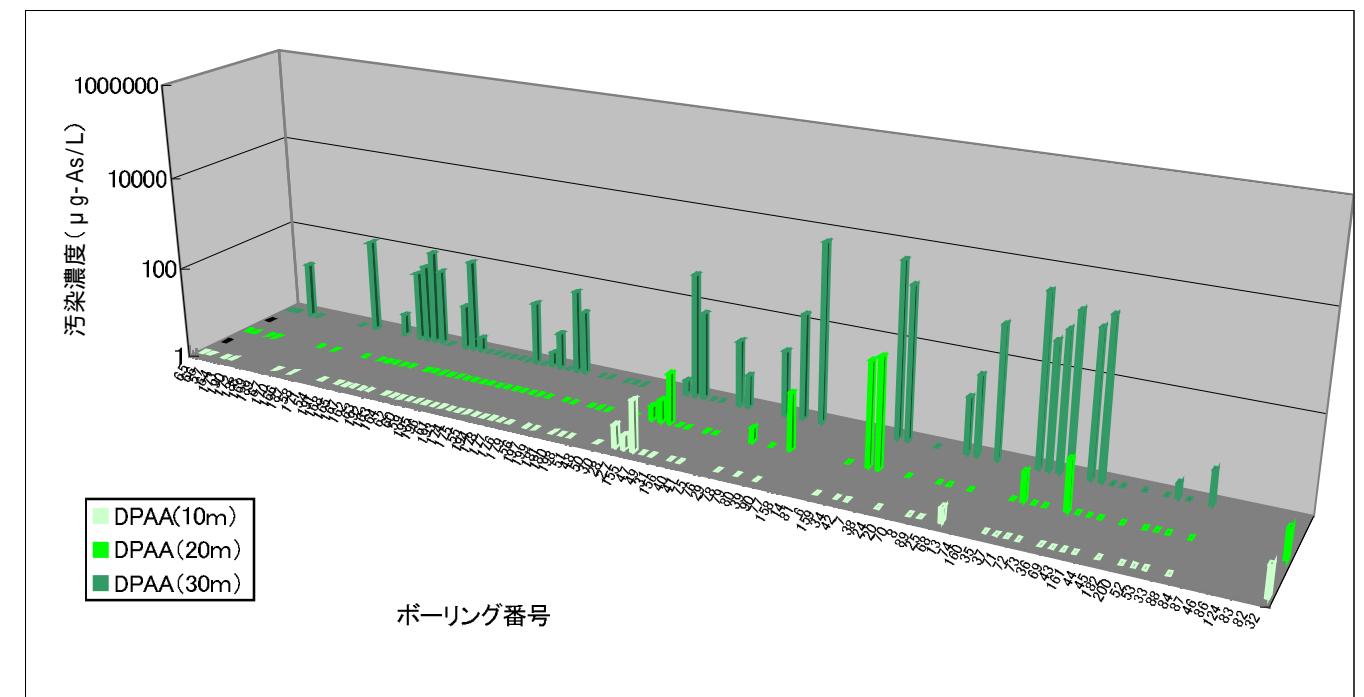
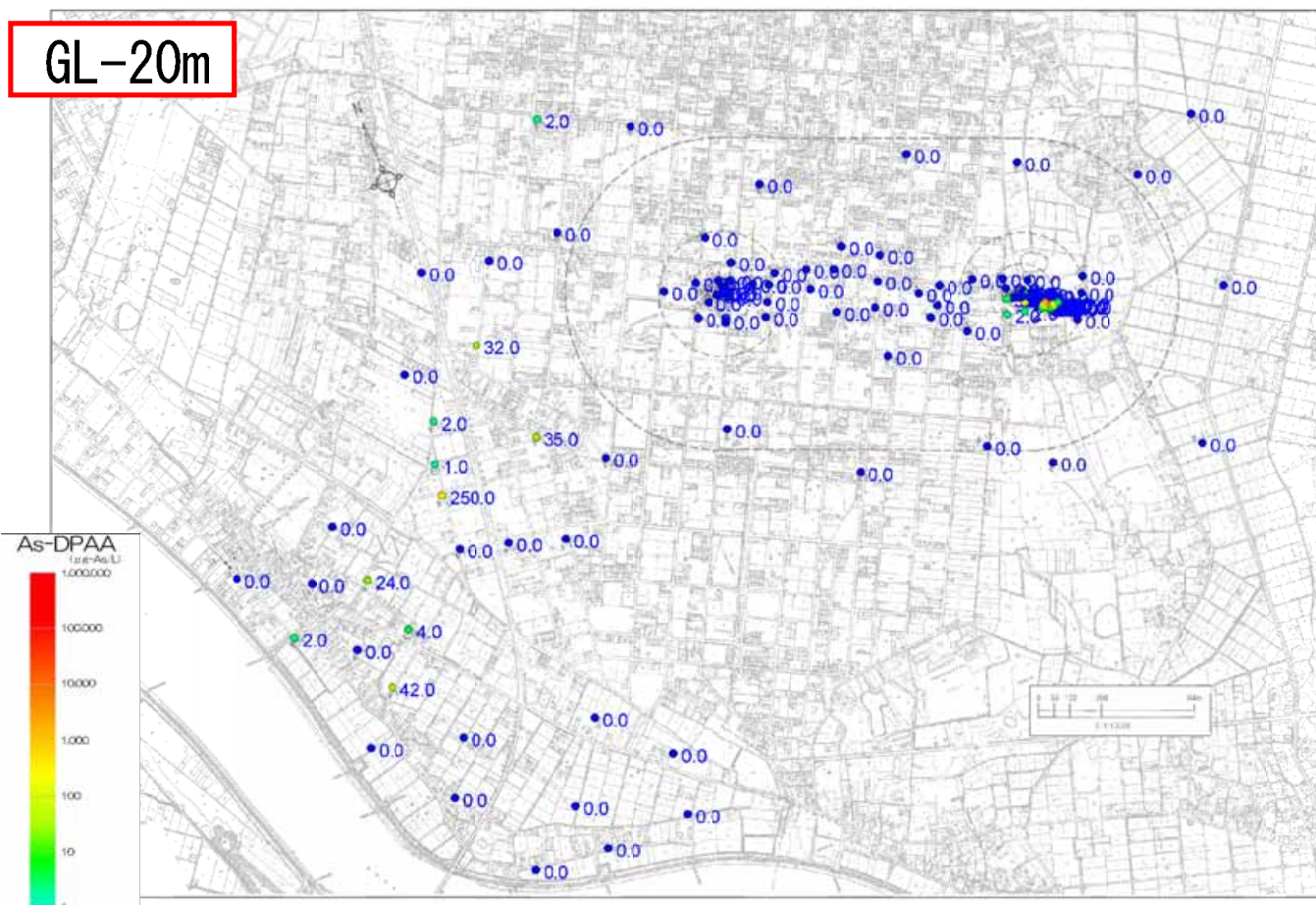
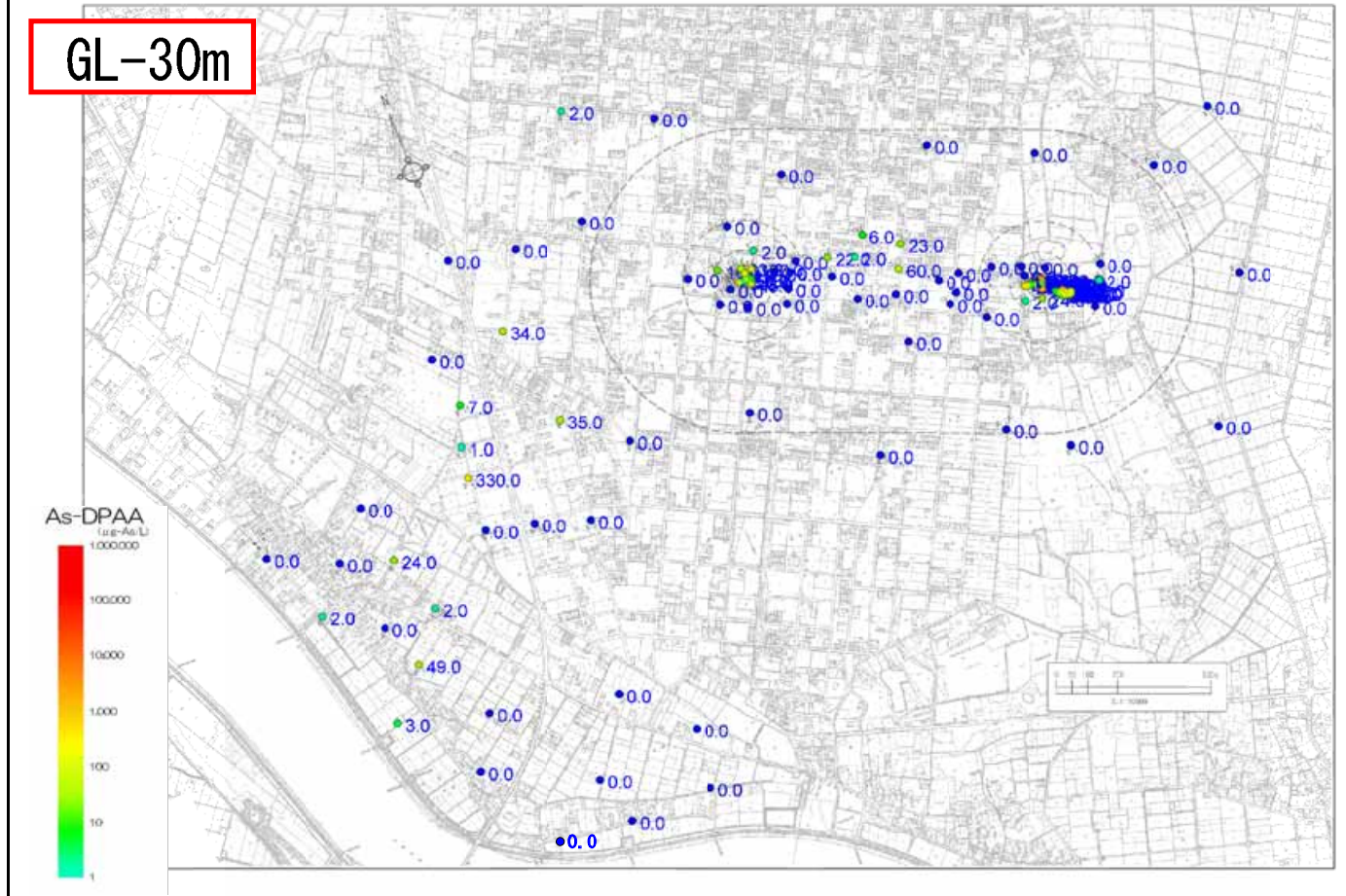
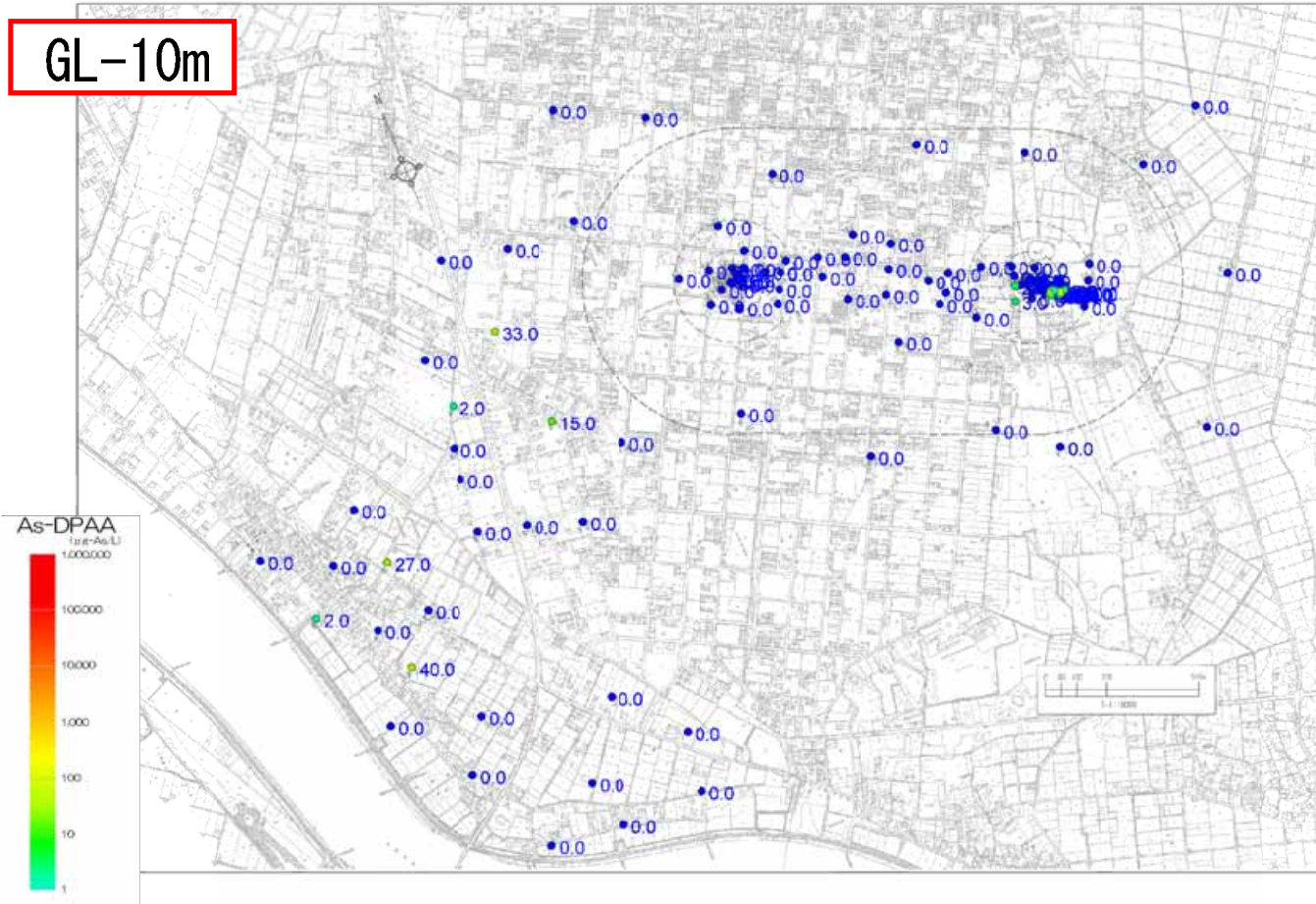
参考図2.4.53 2008年秋季(10月)B地区地下水DPAA汚染状況図
