# Beyond 2020 Framework (post-SAICM) Development Process

- In preparation for the Fifth Session of the International Conference on Chemicals Management, discussions began on a framework for proper management of chemicals and waste beyond 2020 (Beyond 2020).
- Due to the impact of the spread of COVID-19, the scheduled dates of meetings/conference after 2020, when the post-SAICM was originally expected to be adopted, have been significantly delayed. The post-SAICM is scheduled to be adopted in September 2023.

# Summary of Results of SAICM Resumed Fourth Meeting of the Intersessional Process (IP4.2)

 A consolidated version of the negotiating text for the next framework was prepared at the Fourth Meeting of the Intersessional Process (IP4), and a resumed meeting was held for further discussions.

- ODiscussions on three main themes
  - Theme 1: Vision, strategic objectives and targets, and measurement framework
  - Theme 2: Implementation programms, issues of concern (provisional), contributions of diverse sectors, progress management, etc.
  - Theme 3: Capacity building, financial considerations (funding, private-sector involvement, etc.)
- OSubjects other than the above three themes were discussed at the meetings of "Friends of Co-chairs" (FOCC) convened by the co-chairs and the informal dialogues under the FOCC.
  - FOCC: Structure of the document, introduction, principles and approaches Informal dialogues: Elements of the resolution at ICCM5
- OThe document was not finalized at IP4.2. <u>IP4.3 will be held for two days just before ICCM5 in September 2023.</u>

## **Enhancement of Multisectoral Engagement**

 Measures to enhance the engagement of various sectors are being considered in the next framework.

#### Industrial world

- · Strengthen engagement across value chains (clarification of roles)
- Due diligence to ensure a certain levels of chemicals and waste management.
- Support strategic objectives and targets, and commit to innovation, training, etc.

#### Public sector, etc.

 Safe and sustainable chemicals and waste policies, contracts and initiatives at workplaces and in local communities, procurement policies that prioritize protective initiatives, etc.

#### Health sector

 Use the WHO Chemicals Road Map as a tool to facilitate cross-functional collaboration and identify specific activities.

#### Labor sector

- Protect all workers from hazardous chemicals and waste throughout supply chains.
- Integrate initiatives at workplaces such as conclusion and implementation of ILO standards, etc.

#### Financial sector

 Develop policies, guidance and recommendations to promote investment in safer chemicals management through development of sustainable loans and financing standards, etc.
