5. Outline of presentations and discussions

Ms. Urakami from the Ministry of the Environment, Japan provided overviews of background and history of adaptation-related negotiation items under the United Nations Framework Convention on Climate Change (UNFCCC) as well as institutional structure. She also introduced the result of 1st workshop on monitoring and evaluation of adaptation in September 2013 in order to facilitate the enhanced implementation of adaptation and actions as the latest update. Indonesian governments, namely, National Council on Climate Change (DNPI) and Ministry of Finance, presented the current status and way forward of national adaptation plan and update on agricultural insurance. Mr. Ari pointed enormous impact of climate change and vulnerability in Indonesia and introduced preparation of national action plan in recognizing the importance of integration of climate change adaptation into national and regional development planning. Mr. Ifra identified that risk reduction of rice production is essential in terms of sustainable supply and demand of food and explained that Indonesia allocates budget in total Rp approximately US\$ 30 million in year 2014 for agriculture insurance in order to achieve the target of rice production increase. He also introduced that introduction of agricultural insurance is required under the Farmer Protection and Empowerment Act passed in July this year as well as the current progress of pilot activity on agricultural insurance supported by JICA. Then event was closed with presentation by Dr. Warner from MCII/UNU-EHS on innovative climate insurance solutions for climate change which was shared findings on how to integrate climate risk insurance into a comprehensive climate risk management approach based on their project on climate risk insurance conducted by MCII and GIZ jointly.
