Press Accreditation

1. Outline of the G8 Environment Ministers Meeting

Prior to the Group of Eight (G8) Summit, the G8 Environment Ministers Meeting is held with the attendance of ministers of the G8 countries responsible for the environment to exchange opinions on various environmental issues. It is held on annual basis and hosted by the country chairing the G8 Summit.

In recent years, global environmental issues such as climate change have become major international political issues. In reflection of this, environmental issues are expected to be among the major topics taken up at the Hokkaido Toyako Summit in July. Consequently, the role played by the G8 Environment Ministers Meeting will be of particular importance.

(1) Dates: May 24 (Sat.) – 26 (Mon.), 2008

(2) Venue: Kobe Portopia Hotel and others

(3) Host: Ministry of the Environment

(4) Themes: Climate Change, Biodiversity and the 3Rs (Reduce, Reuse, Recycle)

- (5) Attendance: Environment ministers of the G8 member countries as well as other outreach countries and representatives of relevant international organizations. (Refer to Attachment 1 "Participating Countries and Organizations")
- (6) Environmental Considerations: We will minimize the environmental impact of the Meeting by, for example, using low emission vehicles for transport to the venue. In particular, we will focus on reducing the greenhouse gas emissions generated through the Meeting. Emissions that are unavoidable will be compensated for through carbon offsetting, including through implementation of emission reduction projects.

2. Press Accreditation

Although this meeting is closed to the public, journalists will be permitted to cover some parts of the meeting including the press conference by the chair, Minister Ichiro Kamoshita on the last day of the Meeting or other ceremonial events by obtaining accreditation beforehand.

All journalists including photo/video/TV journalists, lighting/audio and other technical

staff, assistants and other support staff wishing to cover the meeting are asked to fill in

the on-line registration form at the following website and submit by April 30 (Wed.).

Anyone who has not obtained accreditation in advance will not be permitted to

cover the meeting.

photo-attached IDs. Please note that you will be asked to submit your photograph

(headshot/color) in digital data (JPEG format) through the on-line registration. (Refer to
