

- ③ Greenhouse gas inventories, emission database management, and systems for collecting, managing and utilizing AD and EF;
 ③ Vulnerability and adaptation assessment;

ROLE OF THE GEF: NAI PARTIES

Provision of financial & technical assistance

- Climate change focal area funding
- Special climate fund
- Adaptation fund
- LDC' fund
- Operational issues
 - GEF to adopt streamlined and expedited approach to financing CB activities
 - Elaborate country driven strategy for capacity building activities
- Reporting issues
 - Progress in GEF support for the implementation of framework to be reported annually to the COP

The Role of multilateral agencies / institutions (other than GEF):NAI Parties

- Provision of technical & financial assistance
 - to assist DCs, in particular LDCs & SIDs in implementing framework
- Operational issues
 - encouraged to consult with DCs in formulation of programs and action plans to support CB
 - streamlined & coordinated approach to CB
- Reporting
 - to inform the COP via secretariat of CB activities to assist DCs in implementation of Framework

THE ROLE OF THE UNFCCC SECRETARIAT: NAI PARTIES

- Cooperate with the GEF, IAs, & other entities to facilitate implementation of framework
- Collect, process, compile information on the basis of contents of
 - Natcoms of DCs,
 - Natcoms of AI Parties
 - Reports from the GEF, to assist the COP/SBs, to review progress in implementation of the framework of CB
- To provide reports to the COP at each of its sessions on activities undertaken by NAI Parties, AI Parties and funding agencies to implement framework

Timeframe & planning horizon for capacity building (2/CP.7)

UNFCCC

Adoption of decisions 2/CP.7, 4.CP.7, 5.CP.7 6.CP.7, 7.CP.7 and 10/CP.7 Annual report of the GEF to the COP, should incl. report on progress in the implementation of 2/CP.7

Entry into force of Kyoto Protocol. COP/MOP1 to endorse C-B decisions

First comprehensive review of implementation of CB frameworks in 2/CP.7

Second comprehensive review of the implementation of CB frameworks, in 2/CP.7
