Presumably, elements of resources that can be used for adaptation may exist in many different parts of existing administration structure (while acknowledging that additional resources are also expected). However, many of they are not necessarily prepared for easy-use. Participants may discuss what elements(with non-adaptation label) exist, and how we can collect? What kind of framework is necessary?

As ESCAP's activities broadly covers socio-economic development, many of its activities <u>unconsciously</u> provide opportunities for countries to enhance adaptative capacity/status. As ESCAP is expected to play a key role in adaptation, Mr. Le may introduce its existing resources that many be applied to adaptation-related work

In practice adaptation-related activities are located in different parts of administration work, thus in order to introduce adaptation measures in a cohesive manner, joint efforts by different ministries are crucial

In its intensive and extensive development assistance activities, adaptation has come to be in a spot light. JICA's past (non climate) activities may have a big potential for adaptation measures, and Mr. Kawanishi may introduce how his partners may better use JICA's operation with increased adaptation consideration.

""Adaptation Concerns in Development Planning and Operation "by Ms. Elizabeth Foster Wright, Office of Prime Minister, Cook Island The Ministry of the Environment, as the nodal ministry for climate change issue, is in a position to take an initiative on adaptation. The challenge is that how it can help other relevant ministries integrate adaptation concerns. Yulia may argue possible domestic cooperation framework.

Ms Liz Wright's office(Office of Prime Minister) is located in the center of the Cook Island government, thus has a relatively larger discretion in decision making on development planning. Now her challenge may be how her office can integrate/digest adaptation-related knowledge. Her experience from planners' side may help others understand "integrator/mainstreamers' needs.

USAID's climate change adaptation program seeks to assist Missions and other development partners to build resilience to climate change through a variety of activities. Since development assistance programs need to be resilient to changing climate and environmental conditions to ensure long-term effectiveness, USAID has elaborated systematic approach and also elaborated Adaptation Guidance Manual. Oresta's presentation on Agency's experiences may bring you with more visualized idea on effective tools for adaptation in development assistance. (you may wish to visit USAID's website as below)
