#### **BACKGROUND**

- established by Ministerial Decree No 15/2002
- Framework Agreement signed on 29 Oct 2004
- Supported by 10 countries: Indonesia, Brunei Darussalam, Cambodia, Lao, Malaysia, Singapore, Philippines, Thailand, Vietnam
- Endorsed by Presidential Regulation No. 60/2005 on 12 October 2005
- New Executive Director approved by SBC
- Offices: Serpong and Jakarta

### ROLE AND RESPONSIBILITY

- Provide services for the implementation of Basel Convention to the Parties (Brunei Darussalam, Cambodia, Indonesia, Lao, Malaysia, Myanmar, Philippines, Singapore, Thailand, Vietnam)
- Any other Parties to the Basel Convention can be served by the Centre through written communication to the Centre and Secretariat
- May invite participation of NGOs, entity, private sectors organisations, universities and other organisations, subject to the agreement of the Steering Committee
- Core functions: training, technology transfer, information, consulting and awareness raising





Technology Transfer	ESM for electronic wastes and dioxin/furans, development of joint projects on alternative destruction technologies, integrated life-cycle management approach for waste pesticides and other stockpiles of HW (e.g. PCB, used oils)
Information	Guidelines for practitioners on destruction technologies and alternative technologies for HW, technical guidelines on ESM of POPs as wastes
