

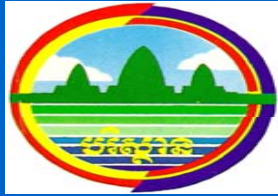

## *1. E Waste Inventory in 2007*

- ☞ Cambodia conducted E Waste Inventory in 2007 under supported fund by Basel Convention.
- ☞ Based on the result of the survey indicated that UEEE imported into Cambodia for domestic consumption have low quality/improperly function need to be either repaired or dismantled.



# 1. E Waste Inventory in 2007 cont.

Second Hand of Electric and Electronic Equipment are imported such as:

- TV
- Air Condition
- Refrigerator
- Set and Laptop Computers
- Mobile phone
- Washing Machine
- Camera
- Radio and cassette player
- Video cassette recorder

## 2. Training Program 2008

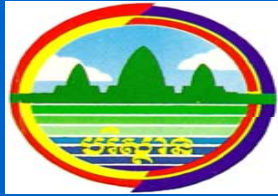
- Under support fund by Basel Convention, Cambodia conducted 6 training programs in Apr-Oct 2008 in 2 cities and 4 provinces.
- Invited participants: MoIEM, MoH, MoC, MoEF Academia, police, monk, post and telecommunication, radio station, NGOs, Customs, CAMCONTROL, Students, Seller, Local authority, NGO's and Waste collection companies.
- Objective:
  - to promote public awareness for all stakeholders related to hazardous waste Management including E Waste.
  - to introduce harmful risk of improper management of hazardous waste as well as E waste.
  - to introduce overview of Basel Convention and Role of Cambodia in Basel Convention



## 3- Waste Management improvement

Government of Cambodia has improved waste management system in the country such as start construction signatory landfill and medical waste incinerator in Phnom Penh city new

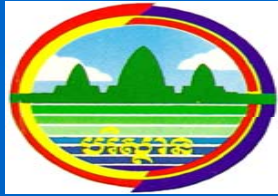




## 4. Future Plan: 1. Pilot Project on E Waste Collection

Establish demonstration of E Waste collection System in area, community or province or city which generate much of E waste in order to Introduce new methodology for proper management of E waste such as EW collection, Transport and storage in environmental manner.





## 4- Future Plan: 2. Set up Regulation or Standards for E Waste Management

Existing law relevant to waste management and prevention of illegal transboundary movement of hazardous waste:

- ☞ *Environmental Law on Natural source Management and Environmental Protection*
- ☞ *Sub-Decree on Solid Waste Management*
- ☞ *Sub-Decree on Waste Water Control*
- ☞ *Sub-Decree on Air Pollution, Noise Disturbance and Vibration*
- ☞ *Sub-Decree on Business Facilitation by Risk Management (2006) is another important legal instrument of Cambodia (MoC)*
- ☞ *Government principle to intercept and ban the importation of old computer/spare-parts of which enter into force on 01 April 2002 (Department of Customs and Excises)*

In order to strengthen effectiveness in proper management of hazardous and prevention of illegal transboundary movement of hazardous waste, Cambodia develop new legal instrument: legislation and standard of hazardous waste management including E waste for prevention and reduction environmental risks.



## *5. Conclusion*

In order to achieve an effectiveness for sound environmental management of hazardous waste as well as full implementation of the convention related to the hazardous waste in Cambodia, some necessary needs and actions should be considered and taken in time, including:

- Establishment National legislation and National Plan related to safe management of hazardous waste,
- Public awareness promotion on hazardous waste management should be broadly conducted at national and local levels,
- Financial and technical assistance for Environmental Sounds Management of Hazardous waste.
