Other Good Practices (1)

–Summary of Questionnaire–

- Good practice for strengthened cooperation with custom and relevant stakeholders

Information sharing meeting	Most of the country
Joint operation with customs	China, HKSAR, Indonesia, Japan, Thailand, Vietnam, etc.
Formulating new strategy / act w/ customs	China, HKSAR
Electronic system to share information on custom clearance	Korea

Other Good Practices (2)

–Summary of Questionnaire–

- Good practice for awareness raising and training activities

IEC material (leaflet, poster, handbook, etc.) for importer/exporter	Brunei, China, HKSAR, Japan, Korea, Philippines, Thailand, etc.
Training, workshop / seminar	Cambodia, HKSAR, Indonesia, Japan, Korea, Philippine, Vietnam, etc.
Consultation service / dedicated hotline	China, HKSAR, Japan, etc.

Other Good Practices (3)

–Summary of Questionnaire–

- Good practice for efficient and user-friendly import/export procedure.

Uploading necessary documents to website	HKSAR, Japan, Philippines, Thailand, etc.
Dedicated consultation service for quick advice	HKSAR, Japan, etc.
Sending notification documents by electronic means (e.g., by fax, email) as well as post	Brunei, HKSAR, Indonesia, Vietnam, etc.

Summary of Questionnaire

- Member countries of the Asian Network have many good practices for implementation of the Basel Convention
- It is valuable to share good practices in order to make use of lessons learned for improving relevant activities in each member country with the purpose of enhancing the overall implementing capability of the region.
- Moreover, through establishing a system to share good practices more effectively and constantly, synergy effects on enforcement activities can be expected by promoting cooperation among member countries.

Benefit of e-handbook of good practice

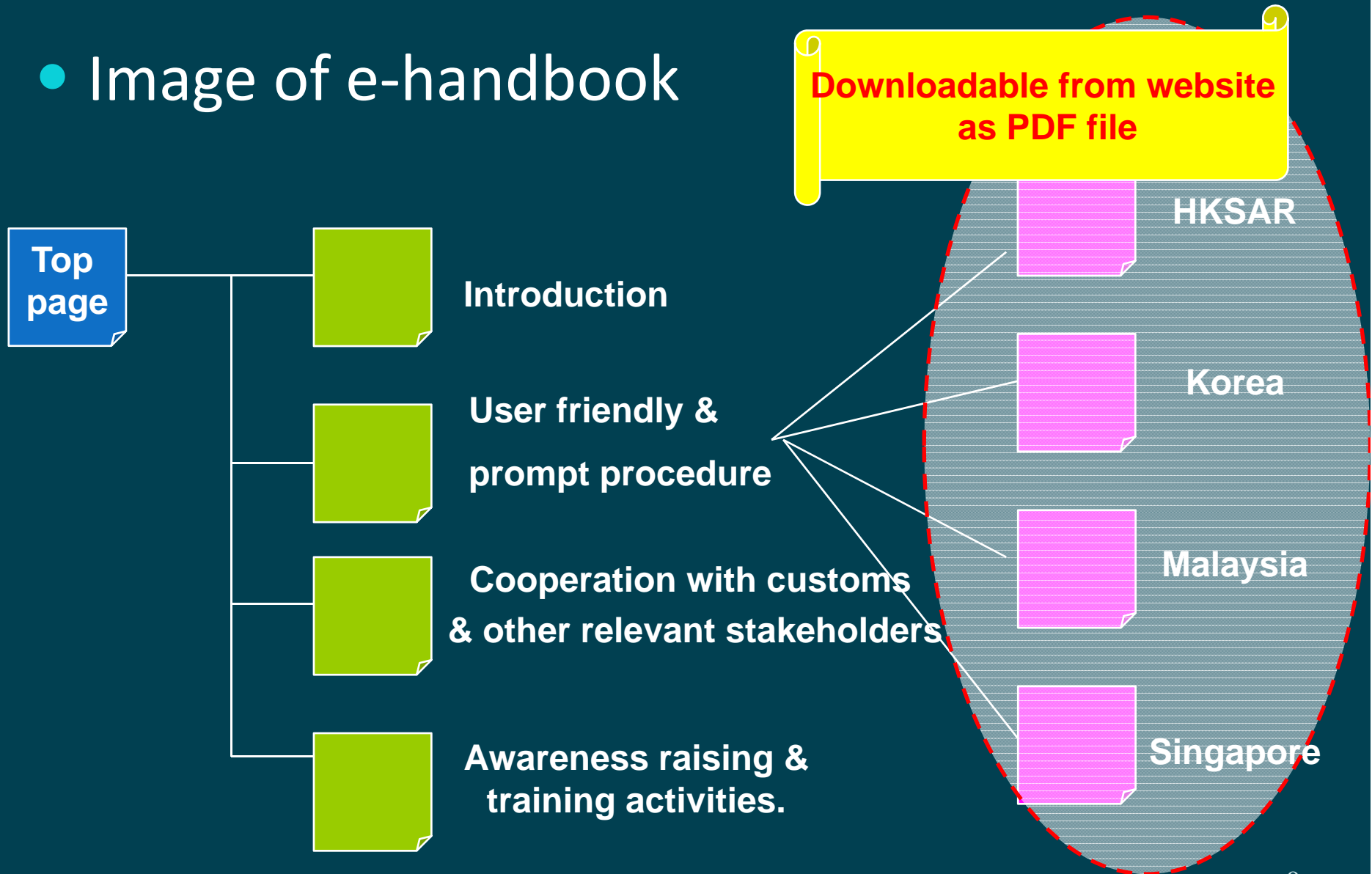
- What benefits can member countries obtain from e-handbook?

Viewpoint of the Secretariats

- Countries can learn and duplicate successful cases of other countries in an efficient manner
- When starting new activities, advice or support can be obtained from well experienced countries.
- Mutual understanding about the Basel import/export procedure among member countries can be enhanced.
- In total, implementation capacity of the Basel Convention can be strengthened in the region.

- Image of e-handbook

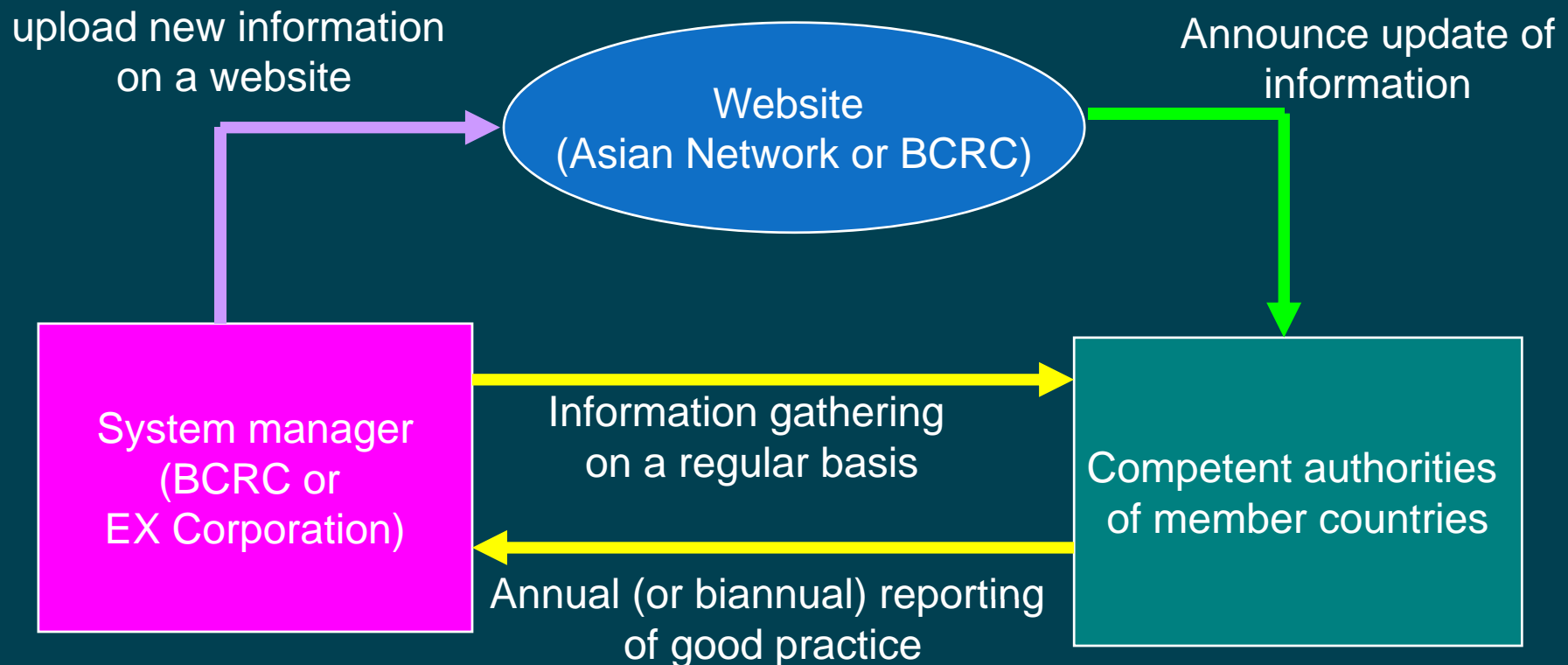


Contents of e- handbook for good practice (proposal from the secretariat)

Chapter		Contents	Typical example
1	Introduction	Purpose of e-handbook and background information	-
2	User friendly and prompt import/export procedure	-On-line application -E-permit system, etc.	Korea, Singapore, Malaysia, HKSAR
3	Cooperation with customs and other relevant stakeholders	-Joint-Inspection with custom -Inter-ministry meeting, -International workshops, -successful case for prevention of illegal TBM, etc.	China, HKSAR
4	Awareness raising and training activities.	-IEC material -Seminar / symposium -Consultation service, etc.	Cambodia, HKSAR, Thailand, Japan
