Hazardous Substance Act

Type of Hazardous Substance

Type 1 Type 2 Type 3 **Ask for Notify Permission DIW** before from DIW **Action Inform DIW before import and export**

Type 4



Prohibit to import, export, production and having possession



Hazardous Substance List

- Chemical wastes (62 items)
 - 61 items: Hazardous waste in Annex 8, List A of the Basel Convention (Type 3 Hazardous Substance)
 - 1 items: Dry cell batteries containing Hg and Cd (Type 4 Hazardous Substance)
- Used electronic and electrical equipments/parts (2 items)
 - Equipments (Type 3 Hazardous Substance)
 - Parts (Type 3 Hazardous Substance)



Used electronic and electrical equipments/parts

- Import of Used EEE is allowed only for objectives
 - Reuse
 - Repair
 - Refurbish as it original purposes (must be used ≤ 5 yrs for photocopier & its parts, except toner cartridge and fuser module; must be used ≤ 3 yrs for others)
 - Disassembly and recycle/recovery (Under the Basel Convention)



Import of controlled waste

- Plastic scraps
 - Prohibit to import unclean and unsorted plastic scraps
 - The cleaned plastic scraps shall be smaller than 2 cm in size except the plastic using as raw material for polyester factories and electronic and electrical factories.
- Used tires and scraps
 - Prohibit to import used tires and scraps



(Tons)




