2005	- AN workshop (December, Tokyo, Japan) - Back-to-back of Inception workshop on ESM of E-waste (Tokyo) ➤ Launch a Asian E-waste project scheme under the Basel Convention
2006	- E-waste Inventory project in four countries (KH, ML, TH, VN) - Research on criteria for waste/non-waste
2007	- Regional workshop (March, Beijing, China) ➤ Launch a research project on TBM of E-wastes and secondhand EEE
2008	- AN workshop (January, Tokyo, Japan)
2009	- AN workshop (January, Kuala Lumpur, Malaysia) ➤ Questionnaire on good practices and import/export procedure ➤ Launch the E-handbook development project
2010	- AN workshop (January, Yokohama, Japan) ➤ Promote collaboration with Customs authority -AN workshop (Siem Reap, Cambodia) ➤ Start discussion on shipback procedure and measures for promoting ESM



Brief Review of the Last Workshop (Siem Reap, Cambodia)

● *The Agenda of the Siem Reap Workshop*

- *Measures for strengthening border control and facilitation of take-back (shipback) procedure*
 - *Measures for promoting environmentally sound management (ESM) of hazardous wastes in Asia*
 - *Future direction of the Asian Network*
- ◆ *The workshop was attended by 33 representatives from 11 countries, 5 from BCRC China and BCRC-SEA, and 16 observers from the relevant intergovernmental organizations and research institute.*
 - ◆ *The workshop was back-to-back with “the 2nd INECE-SESN workshop on combating illegal trade in hazardous wastes through Seaport”*
