The Basel Convention in Thailand

•Thailand ratified the Basel Convention on 24 November 1997 and has enforced since 22 February 1998

- •The Competent Authority (CA) : Department of Industrial Works (DIW), Ministry of Industry
- •The Focal Point (FP): Pollution Control Department (PCD), Ministry of Natural Resources and Environment

•Supporting Agencies: - Custom Department, Ministry of Finance

- Marine Department, Ministry of Transport
- Port Authority of Thailand
- Department of Treaties and Legal Affairs, Department of International Organizations, Ministry of Foreign Affairs, etc.

Thailand's Policy on the Control of Transboundary Movements of HW/E-wastes

- Ban on the import of wastes for final disposal and restriction on the import of wastes for 3Rs
- The Control and Restriction on Import, Transit, and Export of Hazardous Wastes according to Thailand's regulation



Hazardous Substance Act B.E. 2535 (1992)

Classification of Hazardous Substances/Wastes into 4 types



Note: Import mean to bring or order into the Kingdom or to transit

Hazardous Substance Act B.E. 2535 (1992) (cont'd)

- Notification of Ministry of Industry (MoI) on the List of Hazardous Substance B.E. 2546 (2003)
 - Category of Chemical Waste
 - : 61 items of Hazardous Waste in Annex VIII,
 - list A of the Basel Convention
 - : 1 item (as Used lubricant oil)
 - : 1 item (as Dry cell batteries (Hg & Cd) (banned)
 - Category of Used Electrical and Electronic Equipment (EEE)
 - : 32 items of Used EEE
 - : 31 items of its parts





Type 3

Legislation relating to imports of other wastes

- Plastic scraps
 - Prohibit unclean and unsorted plastic scraps
 - Allow cleaned plastic scraps which length is less than 2 cm except plastic used as raw material in polyester factories and electronic and electrical factories.
 - Notification of DIW on Permit Criteria for Importation of Plastic Scrap, 19 Feb. 2008
- Used car tires
 - Prohibit used car tires, except import for research, car racing etc.
 - Notification of Ministry of Commerce on Import of Used Car Tires, 16 Aug. 2013
- Used acid-lead batteries
 - Prohibit used acid-lead batteries (whole and parts)
 - Decision of the National Environment Board, the 2nd-2554, 4 May 2011

New or amended laws/regulations

- Export and Import of Goods Act, No. 2, B.E. 2558 (2015), 10 September 2015
 - Amendment of Export and Import of Goods Act B.E. 2522 (1979)
 - Addition of definition of "transit" and the relevant issues
- Hazardous Substance Act, No..., B.E....
 - Amendment of Hazardous Substance Act, B.E 2535 (1992)
 - Addition of definition of "transit", "re-import", "re-export" and the relevant issues
 - In the process of consideration of the Office of the Council of State

New or amended laws/regulations (cont'd)

- Draft Act on the Management of WEEE, B.E.
 - Specific law on WEEE management based on Extended Producer Responsibility (EPR) principles
 - In the process of consideration of the cabinet which submitted by the Office of the Council of State
- Draft Notification of Ministry of Commerce on Import of Municipal Waste, B.E..., defining Municipal Waste to be prohibited goods
 - Prohibition the unclassified and mixed municipal waste (HS-CODE: 3825.10.00 municipal waste)

Current activities in implementing of the Basel Convention

- •Organizing a workshop on the strengthening of the implementation of the Basel Convention for control the imported/exported hazardous wastes.
- •Defining and considering the control measure for the imported/exported wastes collected from household.
 - •Draft Notification of Ministry of Commerce on Import of Municipal Waste, B.E..., defining Municipal Waste to be the prohibited goods

Current activities in implementing of the Basel Convention (cont'd)

 Preparing to publish the handbook for the Customs Tariff and the specific Statistics Code for wastes covering 451 Statistics Codes

•Preparing to arrange a workshop on the knowledge about the Customs Tariff and the specific Statistics Code for wastes

Implementation of E-Waste Guidelines

- Not yet established guidelines for the distinction between waste and non-waste
- Status of implementation of the E-waste Guidelines
 - Q1 : Difficulties
 - Low awareness of importers/exporters
 - Lack of technical capacity of relevant persons
 - Q2 : paragraph 31 (a) of the guidelines
 - Declaration that none of the UEEE within the shipment is defined as or considered to be waste in any of countries involved in transport.
 - Reason : The importers declare the UEEE according to their objective.
 - The custom officers randomly check the shipment or the suspicious cases.
