## NATIONAL REGULATION ON HAZARDOUS AND NON HAZARDOUS WASTES

- Government Regulation Number 22 Year 2021 regarding the Implementation of Environmental Prevention and Management including Hazardous and Nonhazardous Management (revoked Government Regulation Number 101 Year 2014 Regarding Management of Hazardous and Toxic Waste).
- Regulation of the Minister of Environment and Forestry of the Republic of Indonesia Number 6 Year 2021 regarding Procedures and Requirements of Hazardous Waste Management
- Regulation of the Minister of Environment and Forestry of the Republic of Indonesia Number 19 Year 2021 regarding Procedure of Non Hazardous Management

## **LEGAL BASIC FOR WASTE IMPORTATION**

1. Act No. 32/2009 regarding Environmental Protection and Management, article 69:

Everyone is prohibited to do the following

- a. point (1.c). Bringin in wastes from outside of Indonesia into the living environment of Indonesia (explanation: except for those governed by the law and regulations)
- b. point (1.d). Bringing in hazardous waste into Indonesian territory
- Act No. 18/2008 regarding Domestic Solid Waste Management, article 29: Everyone is prohibited to bringing in domestic solid waste into Indonesia Territory
- Ministry of Trade regulation No. 84/2019 Juncto No. 92/2019 Juncto No. 58/2020 Juncto No. 83/2020 regarding Provision for Importation of Non Hazardous Waste as Industrial Raw Material

#### Renewal of Import Requirements In Accordance with The Regulation of The Minister of Trade No. 84/2019 Juncto No. 92/2019 Juncto No. 58/2020 Juncto No. 83/2020

Prohibition of non hazardous waste being importation are:

 a. does not originate from landfill activities;
 b. not a household/municipal solid waste and/or not mixed with rubbish
 c. not contaminated with hazardous substance and hazardous waste; and
 d. homogeneous.

- Non hazardous waste importer should provide statement letter from the exporter to make sure non hazardous waste being imported is meets the requirements (as above) and willing to take responsibility in doing repatriation of the illegal container to the exporter/origin country
- ✓ Exporter should be a Registered Exporter that already having approval from The Republic of Indonesia representative in origin country and should be the same country with the origin source of non hazardous waste source(valid from 1 January 2021)

## **CURRENT CONDITION OF PLASTIC WASTE POLICY**

- > Product of recycling industry using scrap plastic importation should be end product, means the importer should have the process facility
- The scrap plastic being imported could not being delivered to other recycling industry
- Plastic importer should fulfill the requirement of integrity pact that the scrap plastic importation should not exceed then 50% of facility capacity because the rest should be fulfilled by national source -> the importer should use the plastic waste importation by themselves
- Plastic Industry is being encouraged to use local plastic waste optimally which internally we will support to encourage the mechanism of national collection on plastic waste

## **RESPOND ON PLASTICS AMENDMENT**

- Based on the list of types of plastic waste contained in the appendix of the Minister of Trade of the Republic of Indonesia Regulation No. 84 of 2019, almost all types of plastic waste listed in the Annex of this Regulation as the same as listed in Annex IX of the Basel Convention, except for 2 (two) types of plastic waste which are Polyvinyl Chloride (PVC) and Polyvinyl Acetate (PVA)
- Means that for these two types of plastic waste are categorized into Annex II of the Basel Convention and required PIC procedure.

# **FOLLOW UP NATIONAL ACTIONS**

- 1. Developing the road map on optimizing the used of local plastic waste as raw material for Recycling Industry, with the target:
  - a) To decrease the need of plastic scrap as raw material from importation
  - b) To support the circular economy mechanism in local community (Waste Banks scheme)
- 2. Developing Task Force for Non Hazardous Waste Importation Supervision including oh handling illegal traffic. The task force is coordinated by Ministry of Trade which the members are coming from some related institutions such as: Coordinating Ministry of Maritime Affairs and Investment, MOEF, Ministry of Industry, Ministry of Foreign Affairs, and Custom
- 3. Supervising national surveyor in providing guideline for doing verification in the origin country of waste before shipment
