ORDINANCE SPECIFYING THE REGIONS AND SPECIFIED HAZARDOUS WASTE, ETC. SET FORTH IN ARTICLE 4, PARAGRAPH (2) OF THE LAW FOR THE CONTROL OF EXPORT, IMPORT AND OTHERS OF SPECIFIED HAZARDOUS WASTES AND OTHER WASTES

(Prime Minister's Office and Ministry of International Trade and Industry Joint Ordinance No. 3, October 7, 1993)

The Ordinance Specifying the Regions and Specified Hazardous Wastes, Etc. set forth in Article 4, paragraph (2) of the Law for the Control of Export, Import and Others of Specified Hazardous Wastes and Other Wastes is enacted hereunder pursuant to the provision of Article 4, paragraph (2) of the Law for the Control of Export, Import and Others of Specified Hazardous Wastes and Other Wastes (Law No. 108 of 1992):

(Regions Specified by the Ministry of Economy, Trade and Industry and Ministry of the Environment Joint Ordinance)

Article 1

The regions specified by the Ministry of Economy, Trade and Industry and Ministry of the Environment joint ordinance set forth in Article 4, paragraph (2) of the Law for the Control of Export, Import and Others of Specified Hazardous Wastes and Other Wastes (hereinafter referred to as "the Law") are listed in the middle column of Appended Table.

(Specified Hazardous Wastes, Etc. Specified by the Ministry of Economy, Trade and Industry and Ministry of the Environment Joint Ordinance)

Article 2

Specified hazardous wastes, etc. specified by the Ministry of Economy, Trade and Industry and Ministry of the Environment joint ordinance set forth in Article 4, paragraph (2) of the Law shall be those specified hazardous wastes, etc. listed in the respective right columns of Appended Table with respect to the classification of the regions listed in the middle column of the same Table.

Supplementary Provision

This ordinance shall come into effect as of the date upon which the Law comes into effect.

Supplementary Provisions (Prime Minister's Office and Ministry of International Trade and Industry Joint Ordinance No. 1, March 6, 1997)

This ordinance shall come into effect as of the date of promulgation.

Supplementary Provisions (Prime Minister's Office and Ministry of International Trade and Industry Joint Ordinance No. 9, August 14, 2000)

This ordinance shall come into effect as of the date upon which the Law to Amend a Part of the Cabinet Law (Law No. 88 of 1999) comes into effect (January 6, 2001).
