

3R Portfolio - Good Practices to Promote the 3Rs -

Country: Philippines

Major Activities

1. Promotion of the Concept of Pollution Prevention through Waste Minimization and Recycling

- Implemented the Philippine Industrial Waste Exchange Program (IWEP)
 through the Technical Assistance from International Development Research
 Center (IDRC) Canada [1986-1990] and subsequently transferred
 management of database and program to Business NGO Philippine Business
 for the Environment (PBE)
- Implemented Industrial Environmental Management Project (IEMP) with technical and funding assistance from the US Agency for International Development (USAID [1992-1996] – conducted pollution management appraisals and developed pollution management guidebook on reducing and reusing wastes including exchange for potential raw material of other company

2. Promotion of Waste Segregation and Recycling

- Enacted the law on "Ecological Solid Waste Management Act of 2000" (Republic Act 9003) – mandated the establishment of "Materials Recovery Facilities" (MRF) by the Local Government Units (LGUs) strengthening the enforcement and institutionalization of the principles of 3R
- Enacted the law on "Toxic Substances and Hazardous and Nuclear Waste Control Act of 1990" (Republic Act 6969) – mandated industrial facilities to implement hazardous wastes segregation and recycling program; provided guidelines on import and export of recyclable materials in response to Basel Convention i.e, plastic materials, scrap metals, used oil, electronic assemblies and scraps;
- Forged a tripartite Memorandum of Agreement with an NGO ["Bantay Kalikasan"] and Recycling Industry [Philippine Recyclers Inc., PRI] to strengthen the program on recovery of secondary lead from hazardous waste stream Used Lead-Acid Batteries (ULABs)

3. Enforcement of Hazardous Waste Act (RA 6969)

- Implementation of National Registration of Hazardous Wastes Generation thus establishing a database of facilities generating hazardous wastes, its quantity and rate of generation
- Registration of Treatment, Storage and Disposal (TSD) Facilities for hazardous wastes with different combination of operation either treatment with recovery and disposal or treatment and final disposal;
- Formulation of standards and levels in classifying wastes eligible for direct and recycling

4. Promotion of Philippine Environmental (Public-Private) Partnership Program

- Providing regulatory incentives to facilities and industry associations implementing pollution prevention program leading to compliance with the requirements of international certification on Environmental Management System (EMS)
- Providing assistance in securing funds from Financial Institutions in implementing environmental management programs
