Enforcement Order of Johkasou Act

Cabinet Order No. 310, September 19, 2001 Final revision Cabinet Order No. 17, March 11, 2011

The Cabinet hereby enacts this Cabinet Order based on the provisions of Article 10 paragraph 2, Article 46-2 and Article 50 paragraph 1 specified in the Johkasou Act (Act No. 43, 1983).

(Size of johkasou that need to staff johkasou technical supervisor)

Article 1 The johkasou with specified size by Cabinet Order prescribed in Article 10 paragraph 2 of Johkasou Act (hereinafter referred to as "Act".) should be more than 501 NUD(Number of Users for Design), which is calculated by the method specified in the table of Article 32 paragraph 1 item 1 prescribed in the Enforcement Order of Building Standards Act (Cabinet Order No 338, 1950)

(Replacement of terms of the designated examination institution related to johkasou operator examination, etc.)

Article 2 The technical replacement pursuant to the provision prescribed in Article 46-2 of Act should be as follows table.

- **Article 3** (1) Fees that shall be paid by the person listed in the following items are the amount specified in the following relevant items in according to the provisions of Article 10 paragraph 1 of the Act.
 - (i) Person who intends to renew the approval set forth by Article 16 of the Act (excluding one in the following item) 10,000 yen
 - (ii) For johkasou that has been received the type approval pursuant to Article 13 paragraph 1 or paragraph 2 of the Act (hereinafter referred to as "approved type" in this item) and the approved type of which only unimportant parts are different by the standards set forth by the Minister of Land, Infrastructure, Transport and Tourism (limited to the case that the approved type has been renewed the approval set forth in Article 16 of the Act), person who intends to renew the approval set forth in Article 16 of the Act amount considering the actual cost and specified by the Minister of Land, Infrastructure, Transport and Tourism within the range that not exceeding 10,000 yen
 - (iii) Person who intends to receive issue, reissue or rewrite of certification of johkasou installation worker 2,300 yen
 - (iv) Person who intends to take a johkasou installation worker examination 22,500 yen
 - (v) Person who intends to receive issue, reissue or rewrite of certification of johkasou operator 2,300 yen
 - (vi) Person who intends to take johkasou operator examination 20,200 yen
- (2) The fees set forth in the preceding paragraph shall not be refundable after the payment thereof.
