1. Establishment

In order to implement the Joint Crediting Mechanism (JCM) in Japan in line with the Paris Agreement and other relevant decisions, "JCM Promotion and Utilization Council" is established in the Ministry of the Environment, the Ministry of Economy, Trade and Industry, the Ministry of Foreign Affairs, the Ministry of Agriculture, Forestry and Fisheries, and the Ministry of Land, Infrastructure, Transport and Tourism, which are the JCM implementing authorities, based on the Plan for Global Warming Countermeasures (approved by the Cabinet on October 22, 2021).

2. Mission

The JCM aims to contribute to the ultimate objectives of the United Nations Framework Convention on Climate Change and the objectives of the Paris Agreement by quantitatively evaluating contributions of Japan to greenhouse gas emission reductions and removals, which are achieved through the diffusion of, among others, leading decarbonization technologies, products, systems, services and infrastructure as well as through the implementation of measures in developing countries and others, using such contributions to achieve Japan's Nationally Determined Contribution, and facilitating global actions for emission reductions or removals.

This Council carries out duties relating to the authorization of JCM credits as a Party to the Paris Agreement, the determination of a method to apply a corresponding adjustment to prevent double counting, ~~and the revision of the Guidelines for the Implementation of the JCM and others.~~

3. Composition

In addition, for the implementation of the JCM in Japan in line with the Paris Agreement and the related decisions, as well as the bilateral documents for the JCM and the rules and guidelines adopted by the Joint Council established based on the said documents, the JCM Promotion and Utilization Council is established in the JCM implementing authorities. The JCM Promotion and Utilization Council carries out duties relating to the authorization of JCM credits as a Party to the Paris Agreement, the determination of a method to apply corresponding adjustments to prevent double counting, and the revision of the Guidelines for the Implementation of the JCM.
