About Global Framework on Chemicals (GFC)

The Global Framework on Chemicals (GFC) – For a planet free of harm from chemicals and waste - is a new framework that succeeds the Strategic Approach to International Chemicals Management (SAICM) adopted at the Fifth International Conference on Chemicals Management (ICCM5) in September 2023. The Framework presents a comprehensive plan with five strategic objectives and 28 targets to guide countries and stakeholders in jointly addressing the lifecycle of chemicals, including products and waste.

The framework aims to prevent or, where prevention is not feasible, minimize harm from chemicals and waste to protect the environment and human health. This is a voluntary framework for the management of chemicals throughout their life cycles by multi-stakeholders (Governments, intergovernmental organizations, civil society, industries, academia, etc.) in multi-sectors (agriculture, environment, health, education, finance, development, construction, labor, etc.).

About the Thematic Working Group on Chemical, Waste and Health (TWG-CWH)

The 10th High-Level Officials Meeting of the Asia-Pacific Regional Forum on Health and Environment (APRFHE), the secretariat of which is co-organized by regional offices of the World Health Organization (WHO) and the United Nations Environment Programme (UNEP), was held in September 2019, and it was agreed that the Thematic Working Group on Chemical, Waste and Health (TWG-CWH) was co-chaired by Japan and Thailand from 2020 to 2024, and is now solely chaired by Thailand from 2025.

Since August 2022, we have organized five webinars under the TWG-CWH to help strengthen regional partnership to address chemicals and health issues.
