

**MEMORANDUM OF COOPERATION BETWEEN
THE MINISTRY OF THE ENVIRONMENT OF JAPAN
AND
THE NATIONAL COMMITTEE ON ECOLOGY AND CLIMATE CHANGE
OF THE REPUBLIC OF UZBEKISTAN
IN THE FIELD OF ENVIRONMENTAL PROTECTION**

The Ministry of the Environment of Japan and The National Committee on Ecology and Climate Change of the Republic of Uzbekistan, hereinafter referred to individually as a “Participant” and collectively as “the Participants”,

Considering the global nature of environmental problems and recognizing mutual responsibility for preservation and improvement of the environment,

Striving to expand the cooperation in the field of environmental protection, recognizing the importance of protecting and improving the environment for present and future generations,

Taking into account the experience gained in the field of international environmental cooperation, and

Based on the provisions of international environmental agreements to which the Participants have joined,

Have reached the following recognition:

**Paragraph 1
Objective**

The Participants will cooperate in the field of environmental protection on the basis of equality and mutual benefit, guided by the goals and principles of sustainable development, in accordance with national laws and international agreements applicable in their countries.

**Paragraph 2
Area of Cooperation**

The cooperation under this Memorandum will be in the following areas:

- climate change
- air pollution
- water pollution
- waste management

The cooperation can also be carried out in other areas decided by the Participants.

**Paragraph 3
Implementation of Cooperation**

The cooperation under this Memorandum may take the following forms:

- capacity building through holding meetings, conferences, symposiums, workshops and so on
- information exchange between staff of the Participants or specialists

The cooperation can also be carried out in other forms decided by the Participants.

**Paragraph 4
Modification**

This Memorandum may be modified at any time through mutual consent of the Participants and those modifications will be an integral part of this Memorandum.

**Paragraph 5
Settlement of Divergence**

In case of any divergence regarding the interpretation or application of the paragraphs of this Memorandum, the Participants will resolve them through negotiations and consultations.

**Paragraph 6
Commencement, Duration, Discontinuation and other matters**

The cooperation under this Memorandum will commence on the date of its signature.

The cooperation will continue for a period of three (3) years and be automatically extended for a further period of two (2) years from the date of its discontinuation, up to a total of five (5) years, unless either Participant gives a written notification of non-renewal to the other Participant at least ninety (90) days prior to the discontinuation date.

The cooperation may be discontinued at any time by either Participant by giving a written notification at least six (6) months prior to the date of the intended discontinuation.

The discontinuation of the cooperation will not affect the duration of any ongoing project or activity until the completion of such project or activity, unless the Participants decide otherwise.

This Memorandum will not affect any legal rights and obligations under international law.

The cooperation under this Memorandum is based on voluntary mutual resources. This Memorandum does not impose any financial or legal obligations on the Participants.
