# REGIONAL LAW 27 MARCH 2000 - N. 17 URGENT MEASURES IN TOPIC OF ENERGETIC SAVING TO USE OF EXTERNAL LIGHTING SYSTEM AND FIGHT TO THE LUMINOUS POLLUTION

Article 1 (Purpose)

- 1. The present law, to the aims of established how much from the article 3, codicil 3, points 7, 8, 9 of the Charter of the Lombardy Region, has for deriving purposes the reduction on the regional tentitory of the luminous pollution and the energetic consumptions from it and, and consequently the protection of the activity of scientific and divulgativa search carried out from the professional astronomical observatories of regional or provincial importance or other scientific observatories let alone the conservation of the ecological equilibriums is to the inside that to the outside of the protect natural areas.
- To the aims of the present law it comes considered luminous pollution of the every atmosphere shape of light irradiation crafts them that it is dispersed to outside of the areas to which it functional is didicated and, in particular way, if oriented to of over of the line of the horizon.

# Article 2 (Tasks of the Region)

1. The Region stimulates the adaptation of the existing systems of external lighting system also in relation to the 9 laws January 1991, n. 9 (Norms for energetic the new performance of the Slowly rational one: institutional aspects, center them hydroelectric and elettrodotti, fiscal hydrocarbons and geotermia, autoproduzione and dispositions) and 9 January 1991, n. 10 (Norms for the performance of national the energetic plan in use matter ration them of the energy, energetic saving and development of the rinnovabili sources of energy) for the performance of national the energetic Plan.

2. All the capitolati ones relati you to the public and private lighting system must be consistent to the

purposes of the present law.

# Article 3 (Tasks of the provinces)

1. The province:

 a) exercises the control on the corrected one and rations them use of the energy electrical worker from external lighting system and supplies to disseminate the principle dictates to you from the present law;

b) they cure the writing and the publication of the directory of the common ones in whose territory exists an astronomical observatory from guardian; such directory comprises also the common ones to outside of the provincial territory purche falling back in the indicated bands of protection.

#### Article 4 (Tasks of the common ones)

Common 1.i:

- a) is equipped, within three years from the date of entrance in vigor of the present law, of plans of the lighting system that discipline the new installations in agreement with the present law, detention remaining the dictation of which exactly d) and to article 6, codicil 1;
- b) the systems of external lighting system. Subject to the regimen of the authorization from part of the Mayor

- d) they supply, also upon request of the astronomical observatories or other scientific observatories, to the verification of the points light correspondents to requirement previewed from the present law, arranging so that they do not come modified or replaced or however she conforms to you to the established or teria, within l year from the notification of the stated inadempienza, and, passed these, improrogabilmente within sixty days;

and) they apply, where previewed, the administrative endorsements of which to article 8 employing of the relati to you proceeds for the aims of which to the same article.

### Article 5 (Dispositions in matter of astronomical observatories)

- 1. They are protected from the present one reads the astronomical and astrophysical observatories be them, those professional and not professional ones of regional or provincial importance that scientific search and/or spreading carry out.
- 2. The Regional Committee, within centoventi days from the entrance in vigor of the present law:
- to) it modernizes the directory of the observatories of which to the art.10 also on proposal of the Italian Astronomical Society and the Italian Astrofili Union;
- b) it supplies with appropriate deliberation to determine of the relative one you wrap of respect.
- 3. The Regional Committee supplies moreover, within centoventi days from the entrance in vigor of the present law, to characterize by means of cartography in adequate scale the zones of protection, sending to the common ones interested copy of the cartographic documentation.
- 4. The astronomical observatories:
- to) they signal to the competent territorial authorities sources of light not answering to requirement of the present law, demanding some the participation so that they come modified or replaced or however conformed to the established criteria;
- b) they second collaborate with the territorial agencies for one better and punctual application of the present law their specific competences.
