

「Sino-Japan Low-Carbon Seminar 2010」(Tentative)

In response to issues related to climate change, individual countries are currently considering and taking action to achieve low carbon societies in which relatively low amounts of greenhouse gases (GHGs) are emitted. China too will focus on the development of a low carbon economy as a critical key concept in its next five-year plan (the 12th five-year plan, running from 2011 to 2015).

Given these circumstances, Japan's Ministry of the Environment is organizing the "Sino-Japan Low-Carbon Seminar 2010" in conjunction with Tsinghua University and other organizations. At this event, industrial, academic and governmental stakeholders will come together to share information and promote mutual understanding regarding low carbon societies in Japan and China. Setting the of the seminar as a starting point, the Sino-Japan Low-Carbon Joint study will also be launched this year.

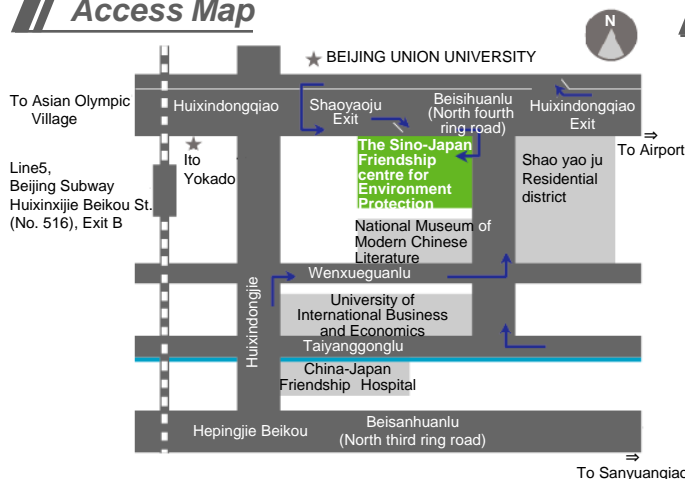
