The World Customs Organization (WCO)

- Established in 1952 as the Customs Co-operation Council (CCC)
- An independent intergovernmental body whose mission is to enhance the effectiveness and efficiency of Customs administrations.

(The only international organization with competence in Customs matters)


- Member Administrations: 182 Customs administrations across the globe.

- Internet based Seizures Database
- Global Database of Customs seizures and offences
- Non-nominal information
- Divided into 15 commodities
- Predefined structure to facilitate data input
- Minimal mandatory data to ensure the quality of analysis


RILO AP plays coordinator roles for joint efforts among member administrations

- Project Savannah : Wildlife
- Operation IRENE II: Small Arms and light weapons
- Operation SESHA II: Rare Timber

Global Operation on Monitoring and Control of Illicit Transboundary Movement of Hazardous Waste and Other Waste



(As of 6 November 2018: Evaluation process on going)

- Initiated by China Customs, coordinated by the WCO Secretariat, RILO AP and China Customs
- The intensive operational phase : from 4 June 2018 to 8 July 2018
- Participating members: 75 Customs Administrations, RILOs and international organizations
- Objective : Enhancing information exchange and cooperative enforcement efforts among Customs across the globe to prevent and intercept illegal cross-border movements of hazardous and other wastes

 were reported


