Point c

(Explanatory article: excluded waste that regulated in other law)

Point d

to bring **Hazarodus wastes into the territory of the Republic of Indonesia**

Point e

to dispose waste into the environment

Point f

to dispose hazardous substance and waste into the environment

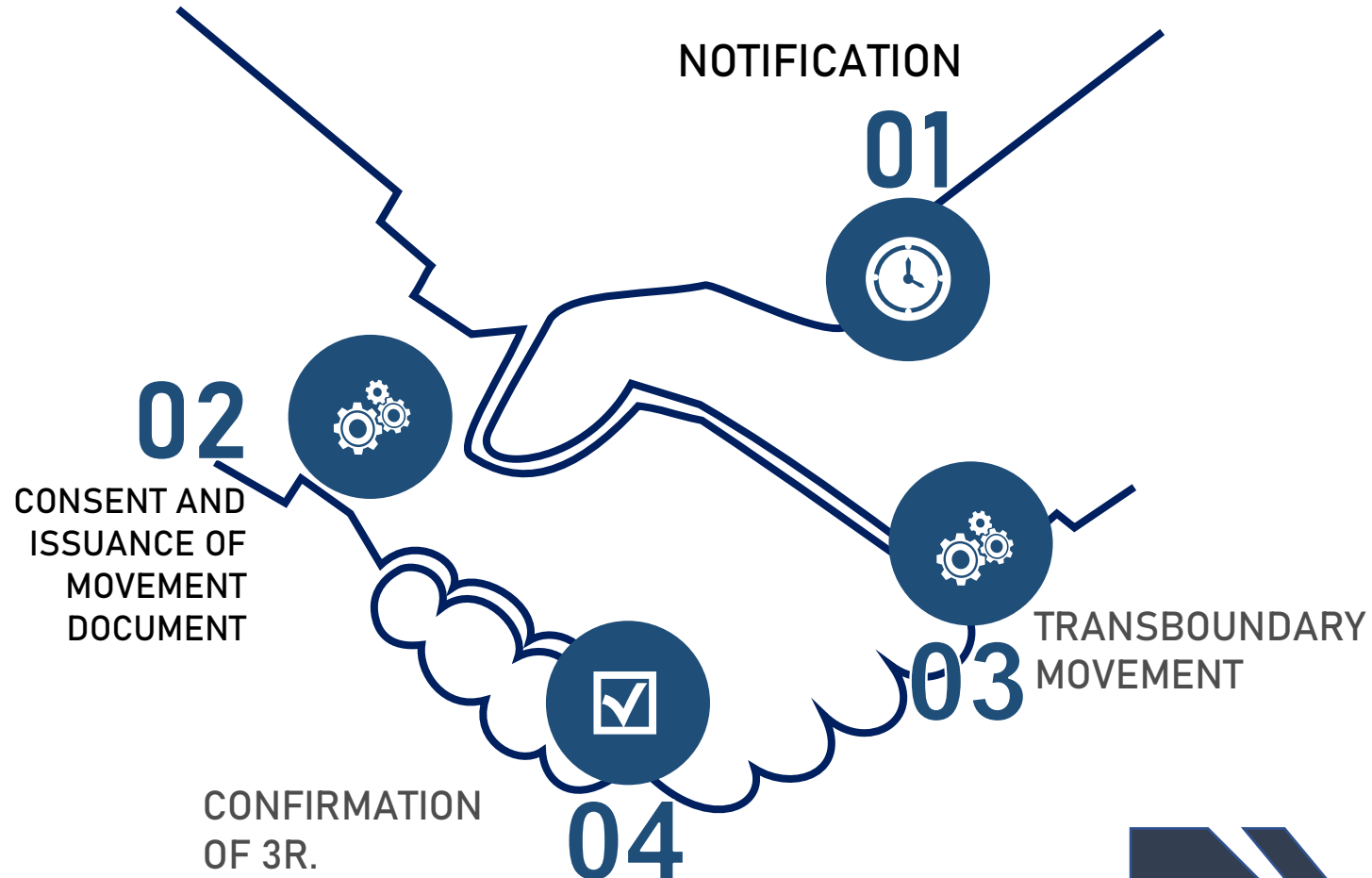

NEED OF RESOURCES



industries still use nonHazardous waste as raw materials and/or auxiliary materials for their production process needs



The availability waste as raw materials and/or auxiliary materials needed for the needs of certain industrial production processes cannot be fully obtained from domestic sources, so additional procurement is necessary from overseas sources.

Industrial Raw Material

waste that can be imported can only be used for industrial raw materials.

Registered Exportir

Imports of Waste as Industrial Raw Materials must come from exporters registered in their country of origin and legalized by representatives of the Republic of Indonesia.

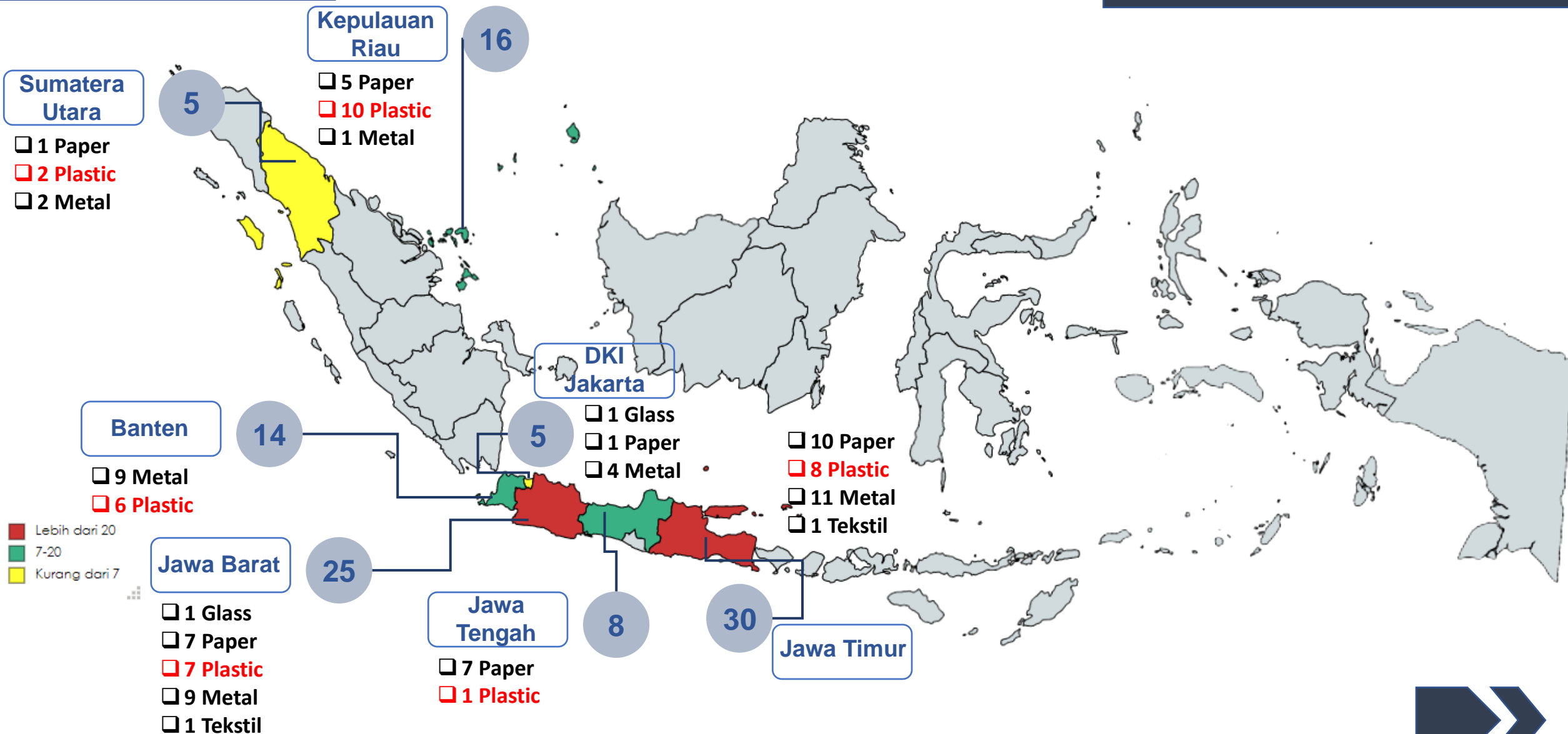

1. Document Validity Statement
2. Environmental Approval Document (already approved)
3. Industrial Business License or Authorized Registration Certificate
4. Taxpayer Identification Number (NPWP)
5. Producer Importer Identification Number (API-P) or Limited Importer Identification Number (API-T)
6. Customs Identity Number (NIK)
7. Temporary storage place for waste (Integrated with Environmental Documents)
8. Pollution control facilities
9. Report on the results of environmental quality monitoring including waste management

The main reason to import Non Hazardous Waste to Indonesia is to meet the needs of industrial raw materials that Indonesia will gradually reduce its dependence on imported waste raw materials (Gov. Policy by 2025 will be fulfilled by local)

02.

To anticipate the occurrence of illegal transboundary waste movements, Indonesia has revised regulations related to the import of waste, namely by requiring registered waste exporters.

03.

The implementation of the PIC for the movement of hazardous plastic waste on January 1, 2021 and electronic waste on January 1, 2025 in accordance with the Basel Convention Decision is expected to further improve supervision of the movement of waste across borders

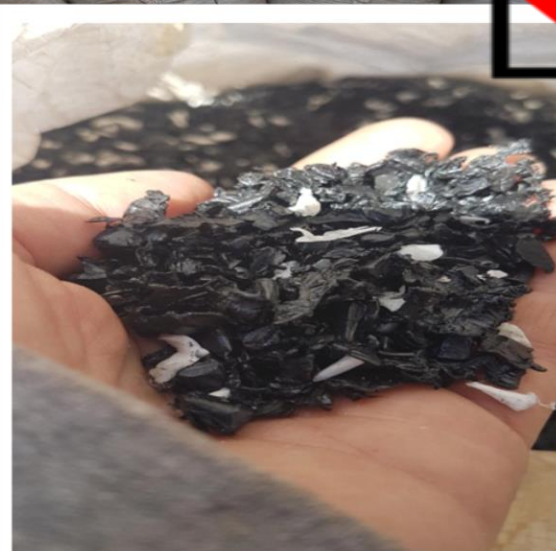

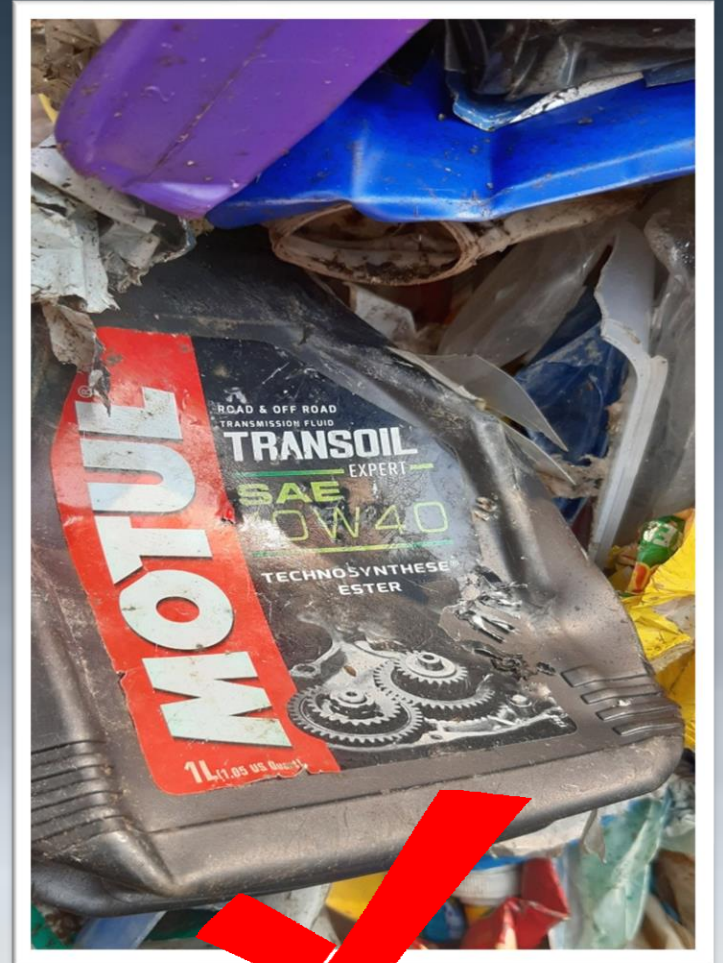

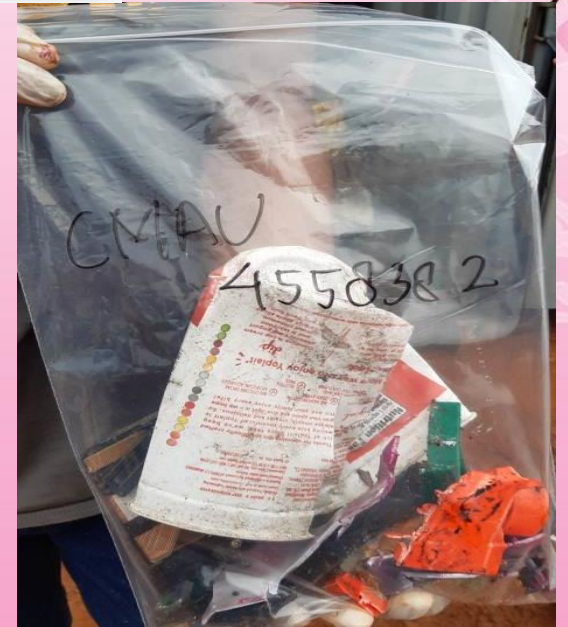
