

Basel regulations in Japan

"Law for the Control of Export, Import and Others of Specified Hazardous Wastes and Other Wastes (Basel Law)"

- > Implementation Law of the Basel Convention in Japan
- Ministerial Order Specifying the Scope of Specified Hazardous Wastes and Other Wastes Based on the Law for the Control of Export, Import and Others of Specified Hazardous Wastes and Other Wastes (Scope Order)" specifies e-waste to be regulated in a listing approach
- <u>Current</u> national regulations of wastes of,,,,
- ✓ Equipment and Component:

<u>4 household appliances, 28 small household appliances</u> and other 4 equipments

✓ <u>Fraction:</u>

not covered clearly by scope order

- **1. Unit type air conditioners**
- 2. Television receivers including Cathode-ray tube type and Liquid crystal display type and plasma type
- 3. Electric refrigerators and electric freezers
- 4. Electric washing machines and clothes dryers
- 5. Telephones, facsimile machines, and other wired communication machinery and appliances
- 6. Mobile telephone terminals, PHS terminals and other radio communication machinery and appliances
- 7. Radio receivers and television communication equipment
- 8. Digital cameras, DVD recorders and other video equipment
- 9. Digital audio players, stereo sets and other electro-acoustic machinery and apparatus
- **10.**Personal computers
- 11.Magnetic disk drives, optical disk drives and other storage devices
- **12.Printers and other printing apparatus**
- 13.Displays and other display devices
- **14.Electronic book terminals**
- **15.Electric sewing machines**
- **16.Electric grinders, electric drills and other power tools**

- **19.Electric inhalers and other electromechanical appliances for medical use 20.Film cameras**
- 21.Rice cookers, microwave ovens and other electrical machinery and kitchen appliances
- 22.Electric fans, electric dehumidifiers and other electric machinery and appliances for air-conditioning
- 23.Electric irons, electric vacuum cleaners and other electric machinery and appliances for clothing or sanitary use
- 24.Electric heater, and other electric machinery and appliances for keeping warm
- 25.Hair dryers, electric razors, and other electric machinery and appliances for hairdressing Small household appliances(2/2)





Different consideration applies to e-waste import and export

Export from Japan
E-waste is processed at importing country

Exports of e-scraps to non-OECD countries have to be strictly examined before the transboundary movement

Import to Japan
E-waste is processed in Japan

✓ At pre-consented recovery facilities with high ESM capabilities \downarrow Imports of e-scraps to Japan are <u>not regulated</u>.

*e-scraps like circuit boards from OECD and non-OECD are <u>the same in nature</u>

Timeline for implementation

- ✓ Jun. 2024: Communication of the adoption of the Annexes amendments from the Depositary of the Basel Convention
- ✓ Oct. 2024: Aim for completion of promulgation of revised relevant National Ministerial Order, Notifications and Guidelines

For export to Japan

✓ Regulations of other countries:

Still collecting information about regulation plans of Asian Countries

✓ Some of components would be regulated under Y49

ex. Motors without mineral oil

✓ Difference between entries of <u>e-waste</u> and

present entries of metal scraps, plastics and metal cables

e-waste: Y49, A1181 metal scraps: B1010, B1020

plastics: Y48, A3210, B3010, B3011 metal cables: A1190, B1115

For import to Japan

- At present, 150,000 tons of electrical and electronic waste and scrap are imported
- ✓ Useful metals are <u>collected and recycled</u>
 - ✓ Should keep smooth importing
 - 1. Import to pre-consented recovery facilities (new applications increased)
 - 2. Other facilities
- ✓ Regulations of other countries
- ✓ Rules during <u>transition period</u> (ex. To pre-consented recovery facilities)

Is it e-waste or other codes?

- ✓ ZORBA (shredded nonferrous scrap)
- ✓ TWITCH (floated fragmentizer aluminum scrap)
- Metal scrap mainly consisting of heavy metals
