AMENDMENT OF MINISTER OF INDUSTRY AND TRADE NUMBER: 756/MPP/Kep/12/2003 REGARDING PROVISION OF NON-NEW CAPITAL GOODS IMPORT

MINISTER OF INDUSTRY AND TRADE THE REPUBLIC OF INDONESIA

Considering:

- a. The implementation of classification system on imported goods as stipulated in Decree of Minister of Finance Number 545/KMK.O1/2003 and in the framework of enhancing the effectiveness of policy on non-new imported capital goods and for the sake of reviving domestic industry as well as attracting investment, it is deemed necessary to amend Decree of Minister of Industry and Trade number 756/MPP/Kep/12/2003 regarding provision of Non-New Capital Goods Import.
- b. Therefore it is deemed necessary to issue Decree of Minister of Industry and Trade.

DECIDE

STIPULATE:

MINISTER OF INDUSTRY AND TRADE THE REPUBLIC OF INDONESIA NUMBER: 610/MPP/Kep/10/2004 REGARDING AMENDMENT OF MINISTER OF INDUSTRY AND TRADE NUMBER: 756/MPP/Kep/12/2003 REGARDING PROVISION OF NON-NEW CAPITAL GOODS IMPORT.

Article I

- 1. Change the list of non-new capital goods which is not allowed to be imported as mentioned in appendix I of Decree of Minister of Industry and Trade number 756/MPP/Kep/12/2003 so that the list of non-new capital goods which is not allowed to be imported is as mentioned in the appendix of this decree.
- 2. Referring to Decree of Minister of Finance Number 545/KMK.O1/2003, the change of the list of non-new capital goods which is not allowed be imported as mentioned in paragraph 1 shall be effective since 1 January 2004.

Article II

- 1. a. Upon the stipulation of this decree all provision stated in Decree of Minister of Industry and Trade number 756/MPP/Kep/12/2003 as well as license and import approval issued based on the decree shall continue to be effective until the expire date of the said license and import approval.
 - b. The License and Import Approval referred to in point a of this decree shall be deemed valid according to article I of this decree and shall be applied pursuant to Decree of Minister of Finance number 545/KMK.01/2003.
- 2. This decree shall come into force on the date of stipulation.

In order the public to be aware of it, this Decree shall be put on the State Gazette of the Republic of Indonesia.
