# Background

- CBD COP10 (October 2010, Nagoya, Japan)
  - ➤ Target 11 of Aichi Targets: "By 2020, at least 17 per cent of terrestrial and inland water areas, and 10 per cent of coastal and marine areas are conserved through systems of protected areas.."
  - ➤ Decision X/31 (Protected Areas): "Conference of the Parties invited Parties to foster the formation of regional initiatives and formulate regional action plans."
- Preliminary Asia Parks Congress

(November 2011, Tokyo, Japan)

- Participants agreed to hold 1st Asia Parks Congress in 2013
- ➤ participants call on the Government of Japan to consider hosting the first Asia Parks Congress and illustrate the role of PAs in post disaster reconstruction as in "Sanriku Fukko (reconstruction) National Park"

# Stream 4: Supporting human life
